The House Committee on Criminal Justice was called to order by Chair Hope.

(MCL 750.147b), as added by 1988 PA 371.

HB 5401 (Rep. Grant) A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16g

of chapter XVII (MCL 777.16g), as amended by

2023 PA 278.
