COMMITTEE MEETING MINUTES

Tuesday, March 14, 20239:00 AMRoom 521, House Office Building

The House Committee on Education was called to order by Chair Koleszar.

Representatives Paquette and Wendzel joined the committee remotely.

Representative Conlin moved to adopt the meeting minutes from March 7, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4166 before the committee:

	PA 23; and to repeal acts and parts of acts.
