#### **Background**



- The A-F system was adopted during the lame duck period of 2018 (Public Act 601 of 2018)
- A-F required MDE to create a school grading system based on 8 indicators.
- The intent was to improve the educational ranking of Michigan, but in reality the system is redundant and pales in comparison to the School Index system.



#### **A-F: A Duplicative System**



- The A-F system is duplicative Michigan already has the Every Student Success Act (ESSA) compliant School Index System for Accountability which meets federal legislative requirements
- The state A-F system was legislated without review of alignment to federal ESSA requirements
- The A-F system cannot be used as a single system for Michigan to meet federal requirements



#### **Alternative Education Campuses**



- A-F exempts the following schools from label and identification:
  - Center programs
  - Strict discipline academies
  - Programs for adjudicated youth
  - Schools that serve specialized student populations
- These schools are designated Alternative Education Campuses



#### **Comprehensive Support and Improvement**



- ESSA requires all indicators be used in determining Comprehensive Support and Improvement (CSI) schools, but the A-F system does not
- A-F limits schools identified for CSI to no more than 5%, while ESSA requires that states identify schools with low graduation rates in addition to this bottom 5%
- Michigan has both federal-CSI and state-CSI schools putting undue burden on districts to understand



#### **Assessment Participation Exemptions**



- Federal requirement allows English Learner students, in their first year in a U.S. public school, to skip a state's ELA assessment
- A-F exempted students with disabilities from testing requirements, which is a violation of federal law ESSA Sec 1111(2)(B) & ESSA Sec 1111(c)(1)(2)(C)



## Public School Academy (PSA/Charter) School Accountability Summarized



- The current Charter School Law holds charter schools accountable to the A-F system.
- We support the recommendation to maintain these accountability requirements in the same form and manner, except now as measured by the federally required School Index system.



- Four cycles: 2018-19, 2019-20, 2020-21, 2021-22
  - Partial results in 2019-20 and 2020-21
- 2021-22 included 3,370 schools
  - 43 total low-performing schools identified (1.4%)
  - 338 Alternative Education Campus (AEC) schools were exempted
  - Only six low-performing schools were identified by A-F that were not already identified by the School Index System

- Four cycles: 2016-17, 2017-18, 2018-19, 2021-22
  - Federal waivers for 2019-20 and 2020-21
- 2021-22 included 3,370 schools
  - 461 schools were identified across all three support categories (13.7%)
  - 255 schools were identified for CSI supports (7.6%)
  - 72 of the 255 School Index CSI schools were alternative education schools
  - 218 schools identified for CSI by the School Index were not identified for CSI by the A-F system
  - 65 of the 218 are alternative schools


