The House Committee on Education was called to order by Chair Koleszar.

The Chair requested attendance be called:

Representative Weiss moved to adopt the meeting minutes from May 16, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4279 and HB 4549 before the committee:

HB 4279 (Rep. VanderWall) A bill to amend 1976 PA 451, entitled "The

revised school code," by amending sections 681 and 684 (MCL 380.681 and 380.684), section 681 as amended by 2016 PA 532 and section 684 as

amended by 2016 PA 535.

HB 4549 (Rep. Shannon) A bill to amend 1976 PA 451, entitled "The

revised school code," by amending section 1233 (MCL 380.1233), as amended by 2021 PA 149.

Representative Greene moved to report out HB 4279 with recommendation. The motion prevailed 12-0-0:
