The House Committee on Education was called to order by Chair Koleszar.

The Chair requested attendance be called:

The Chair laid HB 4752 before the committee:

HB 4752 (Rep. Koleszar)

A bill to amend 1980 PA 300, entitled "The public school employees retirement act of 1979," by amending section 61 (MCL 38.1361), as amended by 2022 PA 184.

Mark Uyl, representing the Michigan High School Athletic Association, joined by John Thompson, representing Athletic Directors, both testified in support of HB 4752.

Alicia Urbain, representing the Michigan Association of Public School Academies, testified in support of HB 4752.

Mac Dashney, representing the Pupil Transportation Operation and Management Institute.
