The House Committee on Elections was called to order by Chair Tsernoglou.

acts and parts of acts.

of criminal procedure," by amending section 11d of chapter XVII (MCL 777.11d), as amended by

2018 PA 661.

HB 4702 (Rep. Tsernoglou) A bill to amend 1954 PA 116, entitled "Michigan

election law," by amending sections 658 and 661 (MCL 168.658 and 168.661), as amended by 2012

PA 270.
