COMMITTEE MEETING MINUTES

Tuesday, September 19, 2023 10:30 AM Room 327, House Office Building

The House Committee on Elections was called to order by Chair Tsernoglou.

The Chair requested attendance be called:

Representative Smit moved to adopt the meeting minutes from September 12, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid SB 385 before the committee:

SB 385	(Sen. Geiss)	A bill to amend 1954 PA 116, entitled "Michigan
		election law," by amending section 677 (MCL
		168.677), as amended by 2018 PA 120.

Chris Swope, representing the Michigan Association of Municipal Clerks, testified in support of SB 385. Questions and discussion followed.

HB 4129 (Rep. Hope)

A bill to amend 1954 PA 116, entitled "Michigan election law," (MCL 168.1 to 168.992) by adding section 931b.

HB 4130 (Rep. Hope)

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 11d of chapter XVII (MCL 777.11d), as amended by 2018 PA 661.

Representative Smit offered the following amendments to HB 4129:

1. Amend page 3, following line 3, by inserting:

"(viii) Engaging in any lawful ballot challenger activities.".

2. Amend page 3, line 7, after "**board**," by inserting "**ballot challenger**,".
