The House Committee on Energy, Communications, and Technology was called to order by Chair Scott.

Representative Andrews moved to adopt the meeting minutes from May 10, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4414 before the committee:

HB 4414 (Rep. Scott)

A bill to amend 1984 PA 431, entitled "The management and budget act," (MCL 18.1101 to 18.1594) by adding section 290.

Representative Coleman moved to adopt substitute (H-1) to HB 4414. The motion prevailed 16-0-0:

HB 4066 (Rep. Coleman)

A bill to create the Michigan high-speed internet office; to prescribe the powers and duties of the Michigan high-speed internet office; to allow the provision of grants and other financial and technical assistance related to broadband and digital infrastructure; and to provide the powers and duties of certain state officers and entities.

Representative Churches moved to adopt substitute (H-1) to HB 4066. The motion prevailed 15-0-1:

"Sec. 11. This act does not apply on or after September 30, 2031.".
