Program Overview

- Food Assistance provides nutrition benefits to supplement the food budget of needy families.
- Accepted at 9,700 unique locations.



What Does Federal Policy Allow to be Purchased Using Food Assistance Benefits?



- Fruits and vegetables.
- Meat, poultry, and fish.
- Dairy products.
- Breads and cereals.
- Other foods such as snack foods and non-alcoholic beverages.
- Seeds and plants, which produce food for the household to eat.




- Beer, wine, liquor, cigarettes, or tobacco.
- Vitamins, medicines, and supplements.
- Live animals.
- Foods that are hot at the point of sale.
- Any items such as:
 - Pet foods
 - Cleaning supplies, paper products, and other household supplies
 - Hygiene items, cosmetics




Applying for Food Assistance

Individuals and families can apply online using MI Bridges or with a paper application.

- Community Partners
 - Provide access to MI Bridges.
 - Assist residents with MI Bridge and paper applications.
- Paper Applications
 - Can be picked up at a local office.
 - Can be mailed to resident with a return envelope by calling MDHHS.







Food Assistance Eligibility

Income



- Wages and selfemployment income.
- Rental income.
- Social Security benefits.
- Veteran benefits.

Asset Limits



- Cash on hand.
- Checking and savings accounts.
- Investments and some trusts.
- Property or real estate.


Expenses



- Shelter.
- Child support payments.
- Dependent care expenses.
- Medical expenses.

COVID-19 Emergency Allotments

- As a result of federal action, COVID-19 Emergency Allotments will no longer be issued effective March 2023.
- Cases will return to pre-pandemic benefit amounts and continue to receive their approved benefit amount based on eligibility factors.
- Cases will no longer receive the additional amount that brings them up to the maximum benefit per month for their group size.
- Cases eligible for the maximum benefit will no longer receive the \$95 Emergency Allotment payment.





Example: Impact to Individuals & Families

- George is a retired individual who lives alone.
- Budgeting his retirement income and household expenses to determine eligibility:
 - He received \$281 in monthly food assistance with COVID-19 Emergency Allotments.
 - When the extra benefits end, he will receive \$112 monthly.

- Mary is a single mother with three kids.
- Budgeting income from her job and household expenses to determine eligibility:
 - Her family received \$939 in monthly food assistance with COVID-19 Emergency Allotments.
 - When the extra benefits end, they will receive \$415 monthly.



Economic Impact

- Every \$1 in food assistance benefits generates \$1.79 in economic activity.
- Emergency Allotments account for an average of \$196 per month per food assistance group.

How MDHHS is Communicating This Change?

- Local office staff are using talking points and FAQs to talk about the change at every touchpoint with a resident.

- Flyers for local offices and community partners.
- Text messaging campaign to those receiving food assistance.
- Tool kit and resources are online 2023 Benefit Changes.
- Social media campaign.
- Press release.
