- Must provide the following to at least three unrelated individuals who are lacksquareaged, mentally ill, developmentally disabled, or physically disabled for 24 hours a day, for 5 or more days a week, for two or more consecutive weeks for compensation:
  - Room
  - Board
  - Supervision
  - Personal Care
  - Protection

### **Care and Services in AFC Facilities**

Care and services provided to AFC residents are designed to maintain and improve a resident's physical and intellectual functioning and independence. All interactions with residents promote and encourage cooperation, self-esteem, selfdirection, independence, and normalization.





- A health facility.
- A nursing home (cannot provide continuous nursing care per MCL 400.703 (4)).
- A Home for the Aged.
- A Substance Use Disorder (SUD) facility.
- A private residence with 1 to 4 residents who all are receiving community mental health (CMH) benefits.
- A home with 2 or less residents receiving care.







- 3,818 licensed AFCs in Michigan.
  - Down about 500 since start of pandemic. \_\_\_\_
- Total capacity to serve over 32,000 residents.  $\bullet$
- Issuing new licenses, renewal inspections and investigations.







## **AFC Licensing Actions**



### Currently no provision for fines in statute.







### **Consultation and Technical Assistance**

Per administrative rule requirements, Licensing Consultants provide advice and technical assistance to providers to assist them in meeting the requirements of the act and administrative licensing rules. They offer consultation upon request in developing methods for the improvement of service.





## **AFC Staffing Requirements**

- 1 staff to 6 residents for AFC family homes (max licensed capacity of 6).
- 1 staff to 12 residents for AFC small group homes, more if necessary to meet the needs of the residents.
- 1 staff to 15 residents during waking hours, 1 staff to 20 residents during sleeping hours for AFC large group homes, more if necessary to meet the needs of the residents.





### **Licensing Consultant Qualifications**

- and family studies.
- disabled population.

All Licensing Consultants have master's degrees, primarily in social work, but also some in psychology, sociology, criminal justice

Many Consultants have previous experience working with the aged, mentally ill, developmentally disabled, and/or physically





- Not less than 18 years of age.
- Able to follow written and oral instructions related to care of residents.
- Suitable to meet the needs of the residents.
- Capable of handling emergency situations.
- Competent before performing assigned tasks including:
  - Reporting requirements
  - Competent in first aid & CPR
  - Personal care, supervision and protection of the residents
  - Resident Rights
  - Safety and fire prevention
  - Prevention and containment of communicable diseases




- Staff must be trained in the proper handling and administration of medications.
- Staff must complete a medication log that includes:
  - The medication
  - The dosage
  - Label instructions for use
  - Time to be administered
  - Initials of person who administers at the time of administration
  - If resident refuses medications\*


