## COMMITTEE MEETING MINUTES

The House Committee on Health Policy was called to order by Chair Rogers.

Representative Coffia moved to adopt the meeting minutes from February 28, 2024. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5077, HB 5078 and HB 5179 before the committee:

HB 5077 (Rep. VanderWall)

A bill to amend 2019 PA 39, entitled "Administration of opioid antagonists act," by amending the title and sections 103 and 107 (MCL 15.673 and 15.677), section 107 as amended by 2020 PA 321, and by adding section 106.

HB 5078 (Rep. Rheingans)

A bill to amend 1978 PA 368, entitled "Public health code," by amending section 17744b (MCL 333.17744b), as amended by 2019 PA 36.

HB 5179 (Rep. Rheingans)

A bill to amend 1978 PA 368, entitled "Public health code," by amending section 7451 (MCL 333.7451), as added by 1988 PA 139.

HB 4747 (Rep. Kuhn)	A bill to amend 1974 PA 258, entitled "Mental health code," by amending section 429 (MCL 330.1429), as amended by 2022 PA 214.
HB 4748 (Rep. Tisdel)	A bill to amend 1974 PA 258, entitled "Mental health code," (MCL 330.1001 to 330.2106) by adding section 469b.

HB 5013 (Rep. Rogers)

A bill to amend 1956 PA 218, entitled "The insurance code of 1956," (MCL 500.100 to 500.8302) by adding section 3406z.
