COMMITTEE MEETING MINUTES

Wednesday, October 11, 2023 10:30 AM Room 326, House Office Building

The House Committee on Higher Education was called to order by Chair Glanville.

The Chair requested attendance be called:

Representative Rheingans moved to adopt the meeting minutes from October 4, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5097 before the committee:

HB 5097 (Rep. Hill)

A bill to create a grant program to assist certain public institutions of higher education in addressing student hunger at those institutions; to provide for the powers and duties of certain state governmental officers and entities; and to require the promulgation of rules.

Representative Hill and Julia Ruth, representing Swipe Out Hunger, testified in support of HB 5097. Questions and discussion followed.

Carmel Price, Associate Professor at the University of Michigan-Dearborn, testified in support of HB 5097. Questions and discussion followed.

Community College Vice President of Finance and Administration, testified in support of HB 5097.

Witwer) | A bill to amend 2020 PA 366, entitled "An act to prohibit postsecondary educational institutions in this state and certain athletic organizations from preventing a college athlete from receiving compensation for the use of his or her name, image, or likeness rights," by amending sections 3, 5, 7, and 10 (MCL 390.1733, 390.1735, 390.1737, and 390.1740). |
