## **COMMITTEE MEETING MINUTES**

The House Committee on Insurance and Financial Services was called to order by Chair Brenda Carter.

Representative Young moved to adopt the meeting minutes from March 16, 2023. There being no objections, the motion prevailed by unanimous consent.

The Chair laid before the committee a PowerPoint presentation presented by the Michigan Bankers Association.

The Chair laid SB 101 before the committee:

SB 101 (Sen. Anthony)

A bill to amend 1956 PA 218, entitled "The insurance code of 1956," by amending sections 5228, 5230, and 5245 (MCL 500.5228, 500.5230, and 500.5245), as amended by 2020 PA 266.

Remy Gelderloos, Legislative Director for Senator Anthony, the bill sponsor, explained SB 101.

Gabe Basso; Manager of State Governmental Relations at Blue Cross Blue Shield of Michigan testified in support of SB 101.
