# **COMMITTEE MEETING MINUTES**

Wednesday, March 1, 2023

The House Committee on Judiciary was called to order by Chair Breen.

of criminal procedure," by amending section 16a of chapter XVII (MCL 777.16a), as amended by

2010 PA 97.
