COMMITTEE MEETING MINUTES

Wednesday, October 11, 2023 3:08 PM Room 519, House Office Building

The House Committee on Local Government and Municipal Finance was called to order by Chair Fitzgerald.

The Chair requested attendance be called:

Representative Shannon moved to adopt the meeting minutes from October 4, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4861 before the committee:

HB 4861 (Rep. Snyder)

A bill to require the state administrative board to release restrictions on real property in Muskegon County; to provide for the powers and duties of certain state departments in regard to the property; and to provide for disposition of revenue.

Representative Rogers moved to adopt substitute (H-1) to HB 4861. The motion prevailed 12-0-0:

Amanda West, representing the Michigan Department of Treasury, testified in support of HB 5074.
