## **COMMITTEE MEETING MINUTES**

Thursday, September 28, 2023

The House Committee on Natural Resources, Environment, Tourism and Outdoor Recreation was called to order by Chair Pohutsky.

The Chair requested attendance be called:

Representative Paiz moved to adopt the meeting minutes from September 21, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4359 before the committee:

HB 4359 (Rep. Brabec)

A bill to repeal 2016 PA 389, entitled "An act to preempt local ordinances regulating the use, disposition, or sale of, prohibiting or restricting, or imposing any fee, charge, or tax on certain containers," (MCL 445.591 to 445.593).

SB 26 (Sen. Chang)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 5534.

Representative Shannon moved to adopt substitute (H-1) to SB 26. The motion prevailed 8-1-0:

Representative Martin offered the following amendment to SB 26, as substitute (H-1):

1. Amend page 4, following line 7, by inserting:

"(6)Members of the advisory committee are appointed by the director of the department. A majority of the members of the advisory committee constitute a quorum for the transaction of business at a meeting of the committee. A majority of the members present and

serving are required for official action of the committee. The business that the committee may perform shall be conducted at a public meeting of the committee held in compliance with the open meetings act, 1976 PA 267, MCL 15.261 to 15.275. A writing prepared, owned, used, in the possession of, or retained by the committee in the performance of an official function is subject to the freedom of information act, 1976 PA 442, MCL 15.231 to 15.246. Members of the committee shall serve without compensation. The committee shall annually submit to the legislature a report on committee activities and project recommendations". and renumbering the remaining subsections.

Representative Martin moved to adopt the amendment to SB 26, as substitute (H-1). The motion did not prevail 3-6-0:

SB 104	(Sen. Daley)	A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding sections 43528c and 43528d.
SB 105	(Sen. McCann)	A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 40113a (MCL 324.40113a), as amended by 2016 PA 382.
