## COMMITTEE MEETING MINUTES

The House Committee on Regulatory Reform was called to order by Chair Tyrone Carter.

The Chair laid HB 4526, HB 4527 and HB 4528 before the committee:

HB 4526 (Rep. Outman)

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 13f of chapter XVII (MCL 777.13f), as added by 2002 PA 30.

HB 4527 (Rep. Tyrone Carter)

A bill to amend 2006 PA 110, entitled "Michigan zoning enabling act," by amending section 205 (MCL 125.3205), as amended by 2018 PA 366.

HB 4528 (Rep. Witwer)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 9115 (MCL 324.9115), as amended by 2017 PA 40, and by adding part 639.
