## **COMMITTEE MEETING MINUTES**

Tuesday, September 12, 2023 10:30 AM Room 519, House Office Building

The House Committee on Regulatory Reform was called to order by Chair Tyrone Carter.

The Chair laid HB 4562 before the committee:

HB 4562 (Rep. Coleman) A bill to require certain manufacturers of certain digital electronic equipment to make diagnostic, maintenance, and repair parts, tools, and documentation available to independent repair providers and owners of that equipment; to provide remedies; to prescribe civil sanctions; and to provide for the powers and duties of certain state and local governmental officers and entities.
