The House Committee on Transportation, Mobility and Infrastructure was called to order by Chair Shannon.

The Chair laid HB 4126 before the committee:

HB 4126 (Rep. Snyder)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 627 (MCL 257.627), as amended by 2022 PA 52.

Representative Snyder testified in support of HB 4126.

Muskegon County Sheriff Mike Poulin testified in support of HB 4126. Questions and discussion followed.

HB 4512 (Rep. Fitzgerald) A bill to amend 1949 PA 300, entitled "Michigan

vehicle code," by amending section 907 (MCL

257.907), as amended by 2020 PA 382.
