## COMMITTEE MEETING MINUTES

The House Committee on Transportation, Mobility and Infrastructure was called to order by Chair Shannon.

Representative Conlin moved to adopt the meeting minutes from October 3, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4028 before the committee:

HB 4028 (Rep. Zorn)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 722 (MCL 257.722), as amended by 2018 PA 274.

Representative Outman explained [the](#) proposed substitute (H-2) to HB 4028.

Representative Roth moved to adopt substitute (H-2) to HB 4028. The motion prevailed 13-0-0:

Representative McKinney, joined by Judge Derek Meineke, representing the Michigan District Judges Association, both testified in support of HB 5103. Questions and discussion followed.

Erin Schor and Melissa Horste, both representing the Michigan Department of State, joined by Precious Kelly, all testified in support of HB 5103.

Kenneth Dandridge, Andrew Smith, Bryant Gary, Monique Pickens, and Alannah Pickens, all representing Change Me Works, testified in support of HB 5103. Questions and discussion followed.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," (MCL 257.1 to 257.923) by adding section 811gg.
