The House Committee on Transportation, Mobility and Infrastructure was called to order by Chair Shannon.

Representative Hoskins moved to adopt the meeting minutes from May 14, 2024. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5341 and HB 5342 before the committee:

HB 5341 (Rep. BeGole)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending sections 2 and 698 (MCL 257.2 and 257.698), section 2 as amended by 2011 PA 231 and section 698 as amended by 2020 PA 382.

HB 5342 (Rep. Shannon)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 312e (MCL 257.312e), as amended by 2022 PA 193.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending sections 252d, 320a, 707b, 707c, 707d, 732, and 907 (MCL 257.252d, 257.320a, 257.707b, 257.707c, 257.707d, 257.732, and 257.907), section 252d as amended by 2022 PA 89, section 320a as amended by 2023 PA 39, section 707c as amended by 2020 PA 382, section 732 as amended by 2023 PA 40, and section 907 as amended by 2024 PA 22.
