

Dams In Michigan

Over 2,500 Dams

- 1,059 State Regulated Dams
 - Ownership: 75% Private, 25% Public
- 92 FERC Regulated Hydropower Dams
- Roughly 1,370 Unregulated
 - Too Small To Meet Part 315 Size Requirements





State Regulated Dams

FERC Roles:

No Involvement Or Regulatory Authority

MDNR Roles:

- Coordinate With EGLE Staff On Permit Applications
- Act As State Experts In Aquatic Organisms, Terrestrial Wildlife,
 Stream Function, Etc.

EGLE Roles:

- Administer Parts 307, Inland Lake Levels, & Part 315, Dam Safety, Of The NREPA
- Permitting For Dam Work
- Inspections
- Permitting Support For Other Programs







Hydropower Dams

FERC Roles:

- Oversee All Operational & Dam Safety Requirements
- Coordinate With Dam Owner, State & Federal Agencies, Tribes,
 & Public On Licensing & Operations

MDNR Roles:

- Provide Recommendations To FERC
- Represent State's Interest

EGLE Roles:


- No Dam Safety Authority (Exempt From Part 315)
- Provide Section 401 Water Quality Certifications
- Issue Permits For Activities Impacting Inland Lakes & Streams,
 Floodplains, & Wetlands



Dam Risk Reduction Grant Program

Funded At \$13M (PA 87 Of 2021) & \$28.2M (PA 53 Of 2022)

2022-2023 Inaugural Cycle

- Received 57 Pre-proposals
 - Total Of \$51.1M In Funding Requests
- Invited 23 Applicants To Submit Full Applications
 - \$26.5M In Funding Requests
- Awarded \$15.3M From PA 87 & PA 53 Funds
- 16 Total Project Funded
 - 6 Dam Removals
 - 4 Dam Repairs
 - 6 Engineering Studies

Dam Risk Reduction Grant Program

2023-2024 Cycle

- Received 64 Pre-proposals (12% Increase)
 - Total Of \$68.4M In Funding Requests (39% Increase)
- Invited 29 Applicants To Submit Full Applications
 - \$33M In Funding Requests
- Full Applications Currently Under Review
 - Anticipate Announcing Awards In April
- Planning To Award \$14M

Future Cycles

- \$14M In Remaining Funds (2024-2025 Cycle)
- Future Appropriations Needed

Funded At \$6M In PA 87 Of 2021

Dam Safety Emergency Action Fund

DSP Is Currently Completing Two Emergency Dam Removal Projects

Expected Expenditures Of Approximately \$3M

Future Appropriations Will Be Necessary To Replenish Funds Expended

Dam Safety Statute Reforms

Draft Reforms Started In 2021

Based On ASDSO/MDSTF Recommendations

Some Legislative Activity But No Amendments Have Been Made To This Date
