COMMITTEE MEETING MINUTES

Wednesday, May 17, 4:00 Room 352, House Appropriations, State Capitol 2023 PM Building

The House Appropriations Subcommittee on Joint Capital Outlay was called to order by Chair Price.

Representative Steckloff moved to adopt the meeting minutes from May 10, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4282 before the committee:

HB 4282 (Rep. Price)

A bill to provide for a capital outlay program and for certain state departments; to implement the program in the budgetary process; to make appropriations for planning and construction at state institutions and the acquisition of land; to provide for the elimination of fire hazards at the institutions; to provide for special maintenance, remodeling, renovation, or demolition of structures and additions to projects at state institutions; to provide for elimination of occupational safety and health hazards at state agencies and institutions; to provide for the awarding of contracts; and to provide for the expenditure of appropriations under the

supervision of the director of the department of technology, management, and budget and the state administrative board.

Representative Steckloff moved to adopt substitute (H-1) to HB 4282. The motion prevailed 17-0-0:
