## **COMMITTEE MEETING MINUTES**

Thursday, October 5, 2023 10:30 AM Room 326, House Office Building

The House Economic Development and Small Business Subcommittee on Housing was called to order by Chair Coleman.

Representative Andrews moved to adopt the meeting minutes from September 28, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4891 before the committee:

HB 4891 (Rep. Andrews)

A bill to amend 1972 PA 348, entitled "An act to regulate relationships between landlords and tenants relative to rental agreements for rental units; to regulate the payment, repayment, use and investment of security deposits; to provide for commencement and termination inventories of rental units; to provide for termination arrangements relative to rental units; to provide for legal remedies; and to provide penalties," (MCL 554.601 to 554.616) by amending the title and by adding section 7a.

Representative Scott moved to refer HB 4891 to the Committee on Economic Development and Small Business. The motion prevailed 7-4-0:

HB 4878 (Rep. Aiyash)
 An act to prohibit landlords from requiring certain disclosures from certain applicants for rental units or taking adverse actions against certain applicants based on certain disclosures; to provide exceptions; to require the promulgation of rules; to provide remedies; to prescribe civil sanctions; and to provide for the powers and duties of certain state and local governmental officers and entities.

Representative Aiyash, joined by Dr. Niloufer Taber, representing the Vera Institute of Justice, both testified in support of HB 4878. Questions and discussion followed.
