

GLOSSARY

STATE BUDGET TERMS

Gross Appropriations (Gross): The total of all applicable appropriations (statutory spending authorizations) in a budget bill.

Adjusted Gross Appropriations (Adjusted Gross): The net amount of all gross appropriations after subtracting interdepartmental grants (IDGs) and intradepartmental transfers (IDTs).

Lapses: Appropriation amounts that are unspent/unobligated at the end of a fiscal year. Appropriations are automatically terminated at the end of a fiscal year unless otherwise provided by law.

Work Project: A statutorily-authorized account which allows a spending authorization to be carried over from one fiscal year to a succeeding fiscal year or years—i.e., allows funds to be spent over a period of years.

APPROPRIATION BILL TERMS

Line Item: Specific funding amount in an appropriation bill which establishes spending authorization for a particular program or function (may be for a single purpose or for multiple purposes).

Boilerplate: Specific language sections in an appropriation bill which direct, limit or restrict line item expenditures, express legislative intent, and/or require reports.

REVENUE SOURCES

General Fund/General Purpose (GF/GP): Unrestricted General Fund revenue available to fund any activity accounted for in the General Fund; unused GF/GP revenue lapses to the General Fund at the end of a fiscal year.

State Restricted (Restricted): State revenue restricted by state law or outside restriction that is available only for specified purposes; at year-end, unused restricted revenue remains in the restricted fund.

Federal Revenue: Federal grant or matchable revenue dedicated to specific programs.

Local Revenue: Revenue from local units of government.

Private Revenue: Revenue from non-government entities: rents, royalties or interest payments, payments from hospitals or individuals, and gifts and bequests.

Interdepartmental Grant (IDG): Revenue or funds received by one state department from another state department (usually for a service provided by the receiving department).

Intradepartmental Transfer (IDT): Transfers or funds being provided from one appropriation unit to another in the same department.

MAJOR STATE FUNDS

Budget Stabilization Fund (BSF): The countercyclical economic and budget stabilization fund; also known as the "rainy day" fund.

School Aid Fund (SAF): A restricted fund; the primary funding source for K-12 schools and Intermediate School Districts (ISDs).

General Fund: The General Fund (funded from taxes and other general revenue) is used to account for the ordinary operations of a governmental unit that are not accounted for in another fund.

DEPARTMENT OF AGRICULTURE

Public Act 13 of 1921 established the Michigan Department of Agriculture (MDA) to "foster and promote in every possible way the agricultural interests of this state..." Public Act 13 also established the five-member bi-partisan Commission of Agriculture and vested the Commission with general administration of the powers and duties granted to the Department. The Commission provides oversight and executive direction for MDA programs, appoints a director to serve as chief administrative officer of the Department, and approves administrative rules and regulations promulgated by the Department. Members of the Commission of Agriculture are appointed by the Governor, with the consent of the Senate, for four-year terms.

The Department's mission is: "To protect, promote, and preserve the agricultural interests of the people of the State of Michigan." The Department's key programs and priorities include: ensuring food safety and security, protecting animal heath and welfare, managing invasive exotic species, regulating pesticide use, certifying agricultural commodities, ensuring environmental stewardship, protecting consumers, promoting a viable agricultural economy, and providing homeland security.

SECTION 102: EXECUTIVE

The Executive Office provides administrative direction and program oversight for the Department and oversees development of policies, rules, and regulations. This appropriation unit also funds the Department's administrative support functions, the Michigan Agricultural Statistics Service, emergency management functions, and costs of certain commissions and boards.

SECTION 103: DEPARTMENTWIDE

This appropriation unit provides funding for rent and related property management charges.

SECTION 104: FOOD AND DAIRY

This unit provides funding for a variety of food safety programs administered by the MDA and recognizes MDA oversight of local health department food safety inspection activities. Program activities are authorized under the Food Law of 2000 (2000 PA 92), the Manufacturing Milk Law (2001 PA 267) and Grade A Milk Law (2001 PA 266).

Food safety and quality assurance – 115.0 FTE positions	\$12,539,700	<u>Food Safety Program</u> within this line item has three program elements: <i>Food Safety and Inspection</i> is a direct inspection program. The department licenses/regulates/inspects approximately 18,000 food establishments, including food processing plants, retail grocery and convenience stores, distribution centers, markets, and concessions at
		fairs. This program helps prevent the sale of adulterated food products, outbreaks of food-borne disease, and fraud and deception in the sale of food products. The program is also responsible for food recall response. There are approximately 50 field food inspectors.
		<i>Food Service Program</i> is an indirect inspection program. There are approximately 48,000 food service establishments (restaurants, schools, hospitals, etc) in this state subject to licensing. While the department has authority over the program under the Food Law of 2000, inspection and licensing has been delegated to Michigan's 45 local public health departments with funding provided through the Department of Community Health (DCH) budget. The Department of Agriculture has four food service consultants and a part-time program supervisor to provide consultation, evaluation, training, and policy guidance to local public heath department food service inspection programs. The department also supports, in cooperation with DCH and the Department of Environmental Quality (DEQ), a local public health department food service accreditation program to assure minimum inspection and quality assurance standards are met.
		Food Safety Planning and Response Unit conducts emergency response to food-borne illness or contamination outbreaks. [Two employees in this unit are budgeted out of the Emergency management line item in the Executive appropriations unit.]
		<u>Milk Safety and Quality Assurance Program</u> licenses and inspects dairy industry pursuant to the Manufacturing Milk Law (2001 PA 267) and the Grade A Milk Law (2001 PA 266). Those subject to department licensing and Inspection include 2,385 Grade A dairy farms, 74 dairy processing plants (which produce bottled milk, cheese, butter, yogurt, ice cream, and other dairy products), and over 1,200 milk trucks and milk haulers. Program activities ensure a safe, wholesome milk supply for Michigan consumers. Without adequate inspection and oversight, milk could not be shipped out-of-state in accordance with the Pasteurized Milk Ordinance—a national standard for dairy-product sanitation developed by the United States Public Health Service.

SECTION 105: ANIMAL INDUSTRY

This appropriation unit provides funding to protect public health and the health and welfare of domestic animals, livestock, and pets. The State Veterinarian is responsible for overall livestock and poultry disease programs and toxic substance contamination concerns related to animal health.

SECTION 106: PESTICIDE AND PLANT PEST MANAGEMENT

This appropriation unit provides funding for implementation of programs and enforcement of laws concerning exotic and invasive pest management, pesticide and agrichemical sale and use, export commodities, and animal feed and drugs.

The program also monitors medicated animal feed and drugs used in food production systems; inspects facilities that produce animal feeds to ensure the food chain is not compromised by contaminants; inspects grain elevators to ensure basic foodstuffs including grains and dry beans are free from substances hazardous to human/animal health.
		Under the Fertilizer Program within this program area the department licenses and regulates fertilizer manufactures.
		Exotic and Invasive Species Response: Program works to prevent introduction, establishment, and spread of exotic and invasive species (both plant and animal) in Michigan, including detecting incoming exotic pests at high-risk sites, delimiting new infestations, and eradication using science-based control methods.
		Pesticide Certification, Registration, and Enforcement: Program works to protect the environment from adverse effects from pesticide and agrichemical use. Regulates manufacture, sale, use, storage, and disposal of pesticides and agrichemicals; investigates pesticide misuse allegations; and certifies/ licenses business operations.
		<u>Plant Pest and Commodity Certification</u> : Ensures plant and animal products meet quarantine requirements and certification standards. Certifies plants and plant products to meet phytosanitary requirements of international and interstate markets; provides third-party grading services for quality/grade standards. Operations facilitate trade of Michigan-grown agricultural products.

SECTION 107: ENVIRONMENTAL STEWARDSHIP

This appropriation unit funds programs to assist local conservation districts, local governments, drain commissioners, and land users with conservation and development of state soil and water resources. Programs encourage installing and managing sustainable resource protection practices at the local level.

SECTION 108: LABORATORY PROGRAM

This appropriation unit provides funding for analytical and diagnostic testing services and inspection programs for consumers, industry, and government agencies. The Laboratory Division provides scientific and analytical services in support of programs of the MDA and other agencies, both federal and state, and testing and consulting services on a fee basis to Michigan's industry and private citizens. The division operates two laboratories: the Geagley Laboratory in East Lansing and the E. C. Heffron Metrology Laboratory in Williamston.

Sec. 205. Hiring Freeze

Imposes a hiring freeze on state classified civil service.

Sec. 208. Internet Reporting

Requires that MDA use the Internet to fulfill reporting requirements.

Sec. 209. Buy American

Prohibits purchase of foreign goods and services when competitively-priced American goods and services are available; requires that preference be given to Michigan businesses, and Michigan businesses owned and operated by veterans.

Sec. 210. Deprived/Depressed Communities

Requires MDA director to take reasonable steps to ensure businesses in depressed communities compete for/perform contracts to provide services and supplies, and to encourage contractors to subcontract with such businesses.

Sec. 212. Indemnification Payments

Requires AEIDF appropriations to be spent for equine-related purposes.

Prohibits use of funds to enforce electronic ID program for domestic animals other than cattle without specific authorization in statute.

Provides for quarterly report on Bovine TB program.

Sec. 458. Testing of Aquaculture Facilities

Requires MDA support for inspection and testing of aquaculture facilities; indicates legislative intent with regard to Viral Hemorrhagic Septicemia surveillance program.

Sec. 459. Bovine TB Program Positions

Exempts Bovine TB program from hiring freeze.

Sec. 460. Aquaculture Funding

Exempts aquaculture program from any budgetary reductions in FY 2009-10 animal health and welfare programs. The Governor's signing statement indicates that this section is an unconstitutional attempt to amend statute by reference.

Sec. 551. Pesticide and Plant Pest Management

Indicates legislative intent that MDA work with industry to ensure development of sustainable system of third-party inspections of fruits and vegetables.

Sec. 603. Migrant Labor Housing

Requires that MDA apply for any available federal funds to support the migrant labor housing program.

Sec. 604. Local Soil Conservation Districts – VETOED

Directs that department work with local conservation districts on the most efficient use of funding provided in the bill; directs that funding be used to draw down federal funds.

Sec. 606. Environmental Quality Incentives

Requires that MDA actively search for all possible funding sources to be used to match federal funds in the USDA environmental quality incentives program.

Sec. 607. Intercounty Drainage Districts

Indicates legislative intent that MDA continue its activities as provided under the Drain Code.

Sec. 608. Right to Farm - NEW

Exempts Right to Farm from budgetary reductions in FY 2009-10 budget year. The Governor's signing statement indicates that this section is an unconstitutional attempt to amend statute by reference.

Sec. 609. Migrant Labor Housing Inspection Fees - NEW

Indicates legislative intent that Department work with industry to develop a migrant labor housing inspection fee, not to exceed \$5 per farm, effective no later than April 1, 2010.

Sec. 610. Water Withdrawal - NEW

Indicates that \$130,000 funding for water withdrawal program is contingent on the department inputting data received under Section 32708(3) of the Natural Resources and Environmental Protection Act.

Sec. 702. Food Bank – VETOED

Allows the Food Bank Council to expend unused funds for direct food purchase.

Sec. 705. Export Market

Stipulates that state funding to be used to leverage export marketing programs offered by the federal government.

Sec. 706. Agricultural Development

Requires that MDA report (April 1, 2009) on agricultural development and export market development activities.

Sec. 707. Agricultural Development Fund Grants

Requires that MDA, in awarding grants from the fund, give due consideration to the diversity of Michigan agriculture and its economic importance.

Sec. 709. Grape and Wine Industry Council

Requires that MDA provide report (April 1, 2009) describing council activities and accomplishments.

Sec. 710. Export Markets

Allows MDA to match external funding for domestic and international marketing programs to develop new and enhance existing export markets for Michigan agricultural products.

Sec. 711. Collaboration With Michigan Strategic Fund

Indicates legislative intent that Michigan Strategic Fund, in collaborate with MDA, promote business development of Michigan agricultural products to achieve increases in export sales, increase the number of retailers carrying Michigan commodities, and increase sales of Michigan products at chain grocers.

Sec. 712. MDELEG for Agriculture Development – VETOED

Indicates legislative intent that Michigan Strategic Fund, in collaborate with MDA, promote business development of Michigan agricultural products to achieve increases in export sales, increase the number of retailers carrying Michigan commodities, and increase sales of Michigan products at chain grocers.

Sec. 713. Agriculture Development - NEW

Directs that \$100,000 be used for agriculture export market development.

Sec. 801. State Simulcasting Tax Revenue Report - VETOED

Requires that MDA submit a monthly report on state simulcasting tax revenue and license fees. (Section restored in 2009 PA 140.)

Sec. 802. Horse Race Purses and Supplements – VETOED

Allocates \$220,000 for purse supplements at state-licensed pari-mutuel tracks for certain races comprised only of Michigan-bred horses. (Section restored in 2009 PA 140 – with \$140,000 earmark.)

Sec. 803. Thoroughbred Program – VETOED

Allocates \$23,500 of the thoroughbred program line item appropriation to the Michigan United Thoroughbred Breeders and Owners Association to conduct a thoroughbred yearling show. (Section restored in 2009 PA 140 – with \$15,000 earmark.)

Sec. 804. Thoroughbred Owners Awards - VETOED

Provides funding for thoroughbred owners' awards; references Horse Racing Law of 1995. (Section restored in 2009 PA 140.)

Sec. 805. AEIDF Report - VETOED

Requires semi-annual report (November 1, 2008 and April 1, 2009) on appropriations and spending targets (based on revised revenue estimates) for appropriation line items funded from the AEIDF.

Sec. 806. Fairs – VETOED

Requires fairs to publish rules and guidelines for exhibits eligible for state premiums; establishes grievance procedures.

Sec. 807. Purse Supplements – VETOED

Provides for overnight purse supplements. (Section restored in 2008 PA 279.)

Sec. 808. Livestock and Equine Exhibits – VETOED

Earmarks \$91,400 from Premiums-county and state fairs line item for grants for large livestock and equine exhibitors, including Michigan Horse Show Association's Fall Youth Show.

Sec. 809. Youth in Agriculture - VETOED

Allocates \$40,000 from Premiums-county and state fairs line for a grant to promote youth involvement and adult exhibitions in the animal agriculture industry.

Sec. 811. Outstanding Unclaimed Tickets - VETOED

Prohibits using funds for distribution of outstanding winning tickets until they are deposited in the AEIDF; MDA is to provide ten-day notice before funds are spent. (Section restored in 2009 PA 140.)

Sec. 812. Agriculture Equine Fund Payments – VETOED

Requires "timely payments" from AEIDF.

Sec. 901. Criminal Activity Information Rewards – VETOED

Allows racing commissioner to pay rewards up to \$5,800 to individuals who provide information on criminal activity involving the horse racing industry.

Sec. 902. Thoroughbred Purse Escrow – VETOED

Directs that in the event that there is not live thoroughbred meet in 2008 or 2009, all purse and program money appropriated in FY 2007-08 and FY 2008-09 be held in escrow for a period not to exceed 18 months. Governor indicated this provision is not enforceable in that it attempts to amend by reference the Management and Budget Act. (Section restored in 2009 PA 140.)

Sec. 903. Notice of Rule-Making - VETOED

Requires 30 day notice to horsemen's organization prior to submitting proposed administrative rules. (Section restored in 2009 PA 140.)

Sec. 904. Office of Racing Commissioner - VETOED

Indicated legislative intent that the Office of Racing Commissioner be no longer designated a Type I agency.

Sec. 1001. Capital Outlay Farmland and Open Space Development Rights

Stipulates that the appropriation for farmland and open space development acquisition shall be used for the purchase of development rights and the awarding of grants by the agriculture preservation fund board under the Natural Resources and Environmental Protection Act.

Sec. 1002. Capital Outlay Provisions Regarding Lump Sum Payments

Requires that the MDA director allocate lump-sum appropriations made in this act consistent with statutory provisions and the purposes for which funds were appropriated. Limits lump sum appropriation carry forward to no more than three fiscal years following appropriation; provides for lapse of funds to original fund source per Management and Budget Act.

Sec. 1003. Capital Outlay Provisions Regarding Carryforward Authority

Provides appropriation carryforward authority per Management and Budget Act.
