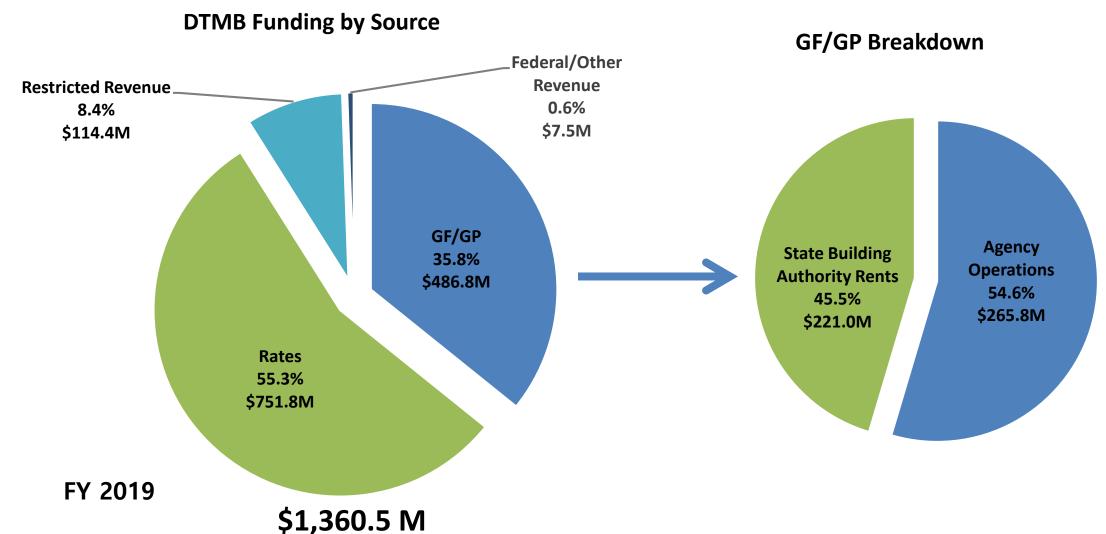

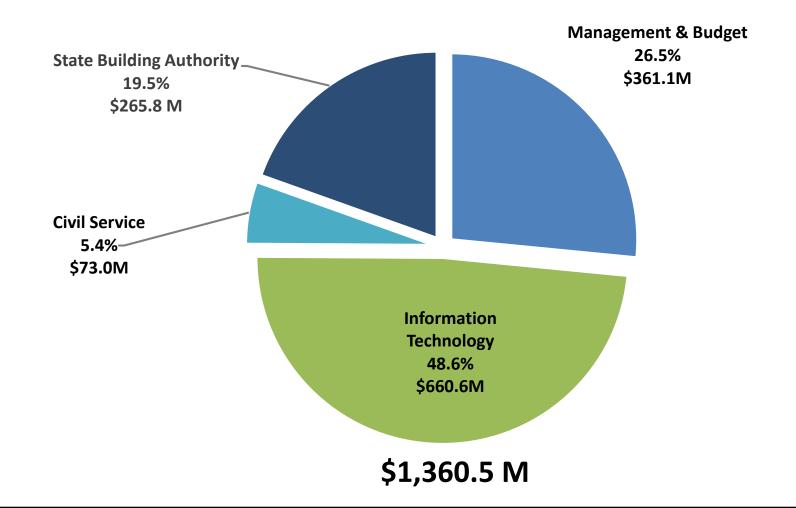
How is DTMB funded?

- Enterprise Portfolio Management \$2,010,000 GF
- Procurement Improvement Plan \$891,900 restricted funds
- Financial Services Support Staff \$559,400 GF/restricted funds
- Building Operations Support \$1,800,000 building occupancy rate
- Pay for Performance \$1,500,000 GF
- FTE Right-sizing \$0 budget impact
- Michigan Cyber Civilian Corps \$420,000 one-time restricted funds

Enterprise Portfolio Management

Request: \$2,010,000 GF

Purpose:

11 new FTEs for project oversight, compliance and audit remediation

Outcomes:

- To provide all IT projects the same level of transparency and quality that ITIF projects receive
- Consistent use of the state's established project management process to track compliance, project success and efficient use of project funds to reduce recurring issues highlighted by the Office of Auditor General
- More efficient management and oversight of contracted project managers



Procurement Improvement Plan Completion

Request: \$891,900 restricted funds

Purpose:

- 3 new FTEs for a contract monitoring program and supplier relationship management
- 3 new FTEs to create a statewide procurement professional development program

Outcomes:

- Ensure contract compliance throughout the life of all state contracts
- Implement supplier risk management process and technology solution
- Establish supplier performance management and formal reporting
- Build strategic supplier identification and continuous business reviews
- Conduct education and enforcement of state procurement law and policies



Financial Services Support Staff

Request: \$559,400 GF/restricted funds

- Funding Breakdown:
 - \$12,900 GF, \$546,500 restricted funds
- Purpose:
 - 6 new FTEs for IT purchasing, accounts payable and invoicing
- Outcomes:
 - Avoid late payment fees with ongoing timely payments to vendors
 - Complete IT purchase requests within approved service level times
 - Increase transparency, accuracy and timeliness of agency bills



Building Operations Support

Request: \$1,800,000 building occupancy rates

- Purpose:
 - Janitorial, elevator and other service cost increases
 - Utility rate increases
- Contributing Factors:
 - Higher minimum wage laws
 - Elevator safety maintenance programs
 - Standardized safety program single point accountability



Pay for Performance

Approved by the rate committee

Request: \$1,500,000 GF

- Purpose:
 - Recruiting and retention of experienced IT employees
- Outcomes:
 - Pay for performance will help attract and retain talented IT/cyber staff
 - Eligibility requirements:
 - Reached the top of the pay scale for more than one year
 - Achieved "high performing" ratings on evaluations
 - Reduce reliance on more expensive contractors



FTE Right-sizing

Purpose:

- 167 FTEs to align with existing statewide appropriations (IT, MSPCS, Building Operations)
- \$0 budget impact
- Contributing Factors:
 - Agency demand for services appropriated and authorized by the Legislature through Interdepartmental Grant (IDG) budget lines. IDGs passed, but didn't align the FTEs.
 - Contractor conversions (efficiency)



Michigan Cyber Civilian Corps

Request: \$420,000 one-time restricted funds

Purpose:

- MiC3 trained cybersecurity experts who volunteer to provide expert assistance to enhance the state's ability to rapidly resolve cyber incidents
- MiC3 mission: collaborate with government, education, private sector organizations and volunteers to create and implement a rapid response team to provide mutual aid to government, education and business organizations in the state of Michigan

Outcomes:

- Provide critical SANS cybersecurity training to the MiC3 members
- Increase MiC3 members
- Improved benefits to employers



Additional Adjustments

• Reductions:

- \$25,000,000 reduction IT Investment Fund reduced from \$65M to \$40M to reset its level going forward now that the implementation of SIGMA is nearly complete
- \$1,000,000 reduction on network equipment

Additions:

- \$31,023,400 IDG Agency requested IT funds aligns funding of the IT IDGs with agency CSB requests
- \$19,200,000 GF State Building Authority Rent
- \$1,500,000 GF Regional Prosperity Grants encourages local, private, public and non-profit partners to create vibrant regional economies



FY 2018 Supplemental

- \$1,750,000 Executive Office Transition
- \$20,000,000 Broadband initiative supports increased connectivity and the expansion of broadband service to unserved and underserved communities in Michigan
- \$100,000 Education governance study
- \$3,000,000 Enterprise-wide special maintenance fund supports demolition of surplus state-owned facilities
