DTMB 2022: A Year in Review



Satisfied customers – 80% of state employees polled during DTMB's Customer Satisfaction Survey said they were satisfied with services they received from DTMB, an increase of five percentage points from 2019.



It's in the mail – In FY 2022, DTMB saved state agencies \$7.7M by presorting first class U.S. mail.



Increased participation in MiDEAL – For the sixth straight year, DTMB's MiDEAL program has increased membership and now includes 1,350 local governments and organizations, allowing members to take advantage of the buying power of State of Michigan contracts, saving time, and money.

DTMB 2022: A Year in Review



Making state government energy efficient – DTMB executed utility agreements with the Lansing Board of Water and Light, Consumers Energy, and DTE to utilize 100% renewable energy by 2025 for all 43 DTMB-managed facilities.



Payment upgrade – DTMB modernized the payment processing platform for the Michigan Secretary of State Offices replacing 800 card readers.



Website modernization – DTMB collaborated with state agencies to migrate all 115 Michigan.gov websites, replacing a 20-year-old system.

DTMB 2022: A Year in Review



Cybersecurity – measures protect against an average of 110B security events per month and block more than 90M attempts on the firewall each day.



MILogin – the state's secure digital identity program, has grown to more than 9M users accessing 300 applications across 16 agencies.






DTMB FY 2024 Funding Breakdown – total gross appropriation \$1.8B




DTMB FY 2024 Funding Breakdown

Environment, Great Lakes, & Energy	Groundwater Data Management System New interactive database providing for the integration of disparate source data into a comprehensive data repository of statewide and regional groundwater in Michigan. Licensing & Regulatory Affairs	Liquor Control Commission - Sales, Inventory and Purchasing System (SIPS) Supports the final phase of the existing SIPS project, bringing the total investment to \$7.8 million. The current project is proceeding as planned and is expected to be complete in fall 2023.	\$900,000
Natural Resources	Enterprise Asset Management System Provides for implementation of an off-the-shelf asset management solution for all DNR-owned properties, facilities, equipment, and energy tracking. The total project cost is \$5 million gross with the addition of state restricted funds.	\$3,500,000
Treasury	City Income Tax Expansion Project adds fiduciary and partnership tax collection for the City of Detroit and provides funds for the voluntary expansion of collection services for the City of Flint and 22 other cities that levy an income tax should they elect to participate.
