## Public Testimony on the Fiscal Year 2021-22 Executive Budget Recommendation for the Department of Health and Human Services

Honorable Representative Mary Whiteford and the Appropriations Subcommittee on Health and Human Services:

My public testimony regarding the FY 2021-22 Executive Budget Recommendations follows.

As a director of a non profit organization that serves people with developmental disabilities, our greatest challenge has always been wages for direct care workers. As an agency that provides community living support services, we serve people with services from hard working people who must feel that the work is well reimbursed.

As it stands today, our starting pay for direct support professionals is \$11 per hour. With the Governor's Premium Pay during the pandemic, our starting pay is \$13 an hour and this has made all the difference to us. Prior to premium pay we had a difficult time hiring and retaining new direct support staff. Since April 2020 we have seen a steady stabilization of new hires and more importantly better rapport and morale for our long term staff who accepted the additional \$2 an hour gratefully.

Community Alliance stands in strong support of the budget recommendation to make permanent the Premium Pay for direct support professionals and to ensure the funds are a direct pass through to the worker. Please ensure the funds are protected for the purpose of paying direct care workers.

Thank you for all your hard work in Lansing. I am happy to speak with any committee member about my public testimony.
