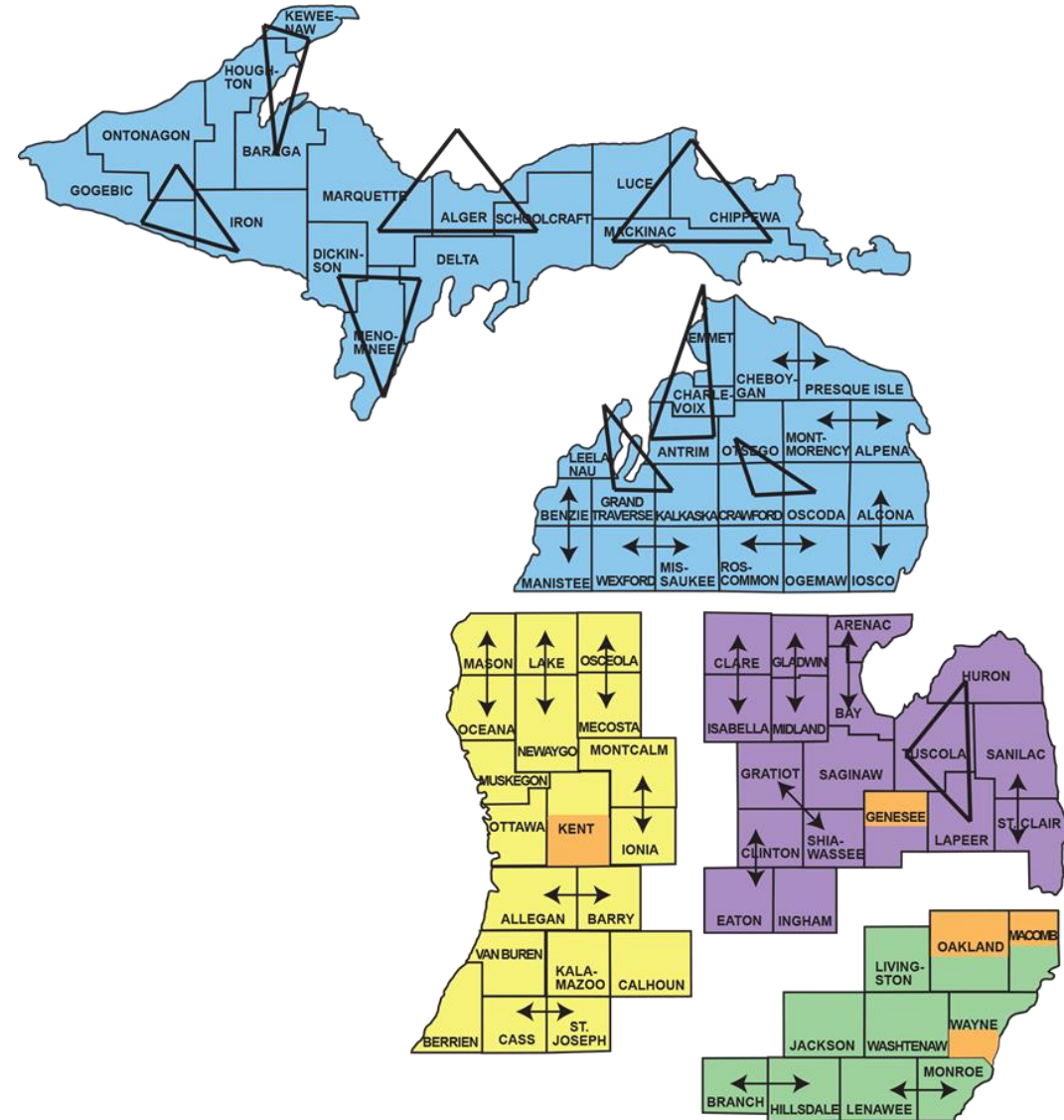

Supplemental Nutrition Assistance Program (SNAP)

Program Eligibility Requirements.*

Residence

- Must be a Michigan resident.

Identity

- Head of Household must verify their identity.

Assets

- Must meet program asset limits.

Income

- Must meet program income limits.

Citizenship

- Must be a federally approved lawfully present individual.

SNAP Continued

1,384,706 average
monthly SNAP recipients.

Summer Electronic Benefits Transfer

In Fiscal Year 2024, \$120,635,520 in benefits issued to 1,005,296 children.

Eligible Children 0-6 years old:

- Enrolled in a school program.
- Meets the financial criteria.
- In foster care, experiencing homelessness, a migrant or a runaway.

Eligible Children 6-18 years old:

- Receiving SNAP, Temporary Assistance for Needy Families (TANF) or Medicaid.
- Approved for free/reduced price meals.
- In foster care, is experiencing homelessness, a migrant or a runaway.

Automatic eligibility for families:

- Benefits must be used within 122 days.

Program Eligibility Requirements*

Residence

- Must be a Michigan resident.

Identity

- Not required to verify identity
- MDHHS has multiple ways to verify identity of applicants

Assets

- Must meet program asset limits.

Income

- Must meet program income limits.

Citizenship

- Must be a federally approved lawfully present individual.

Medicaid Program Background



Medicaid is the **largest health insurance program** in the U.S.

- Medicaid is a means-tested entitlement program providing **comprehensive health coverage for eligible populations**, including:
 - Low-income children and families.
 - Elderly and disabled individuals.
 - Pregnant women.

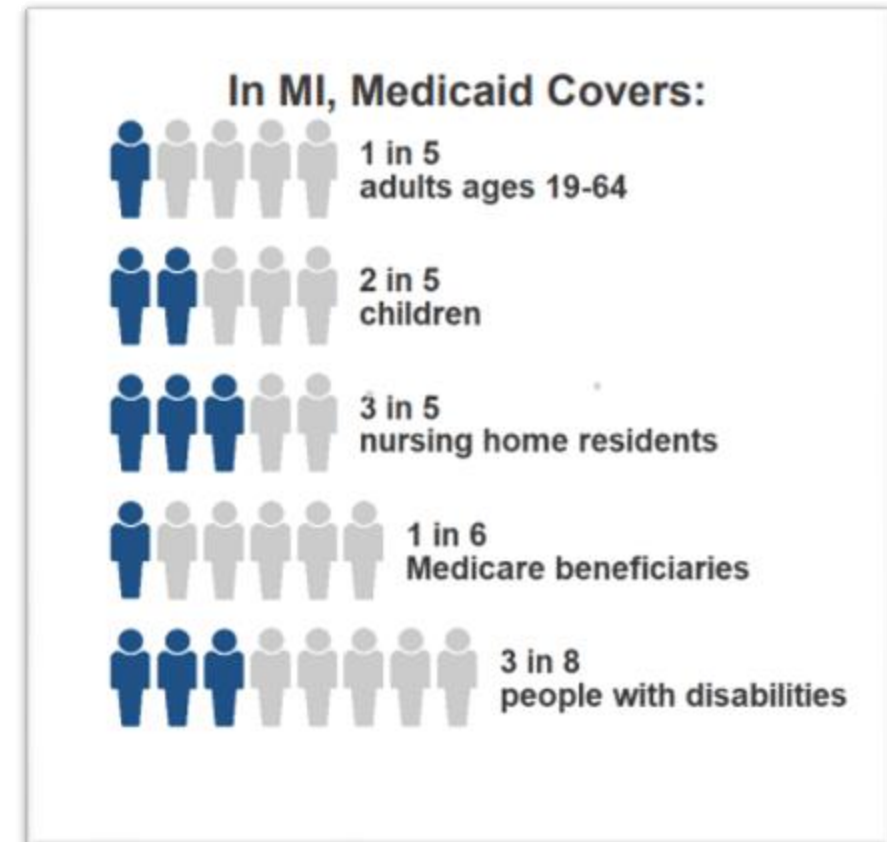
Michigan's Medicaid Program has a Vast Reach

Medicaid covers 1 in 5 individuals living in the U.S. In Michigan, the coverage rate is even higher - 1 in 4 **Michiganders**.

Michigan's Medicaid program affords health coverage to over **2.6 million Michiganders** each month, including:

- **One million children**;
- **300,000 people** living with **disabilities**;
- **168,000 seniors**; and provides:
 - Nearly **725,000 adults** in the **Healthy Michigan Plan**.

45% of births in Michigan are covered by Medicaid.

Child Development and Care

Program Eligibility Requirements.*

MILEAP sets policy, controls the funding and manages provider payments for Child Development and Care.

MDHHS determines eligibility, including approved hours and family contribution (co-payment) requirements.

Residence

- Must be a Michigan resident.

Identity

- Head of Household must verify their identity.

Assets

- Must meet program asset limits.

Income

- Must meet program income limits.

Citizenship

- Must be a federally approved lawfully present individual.

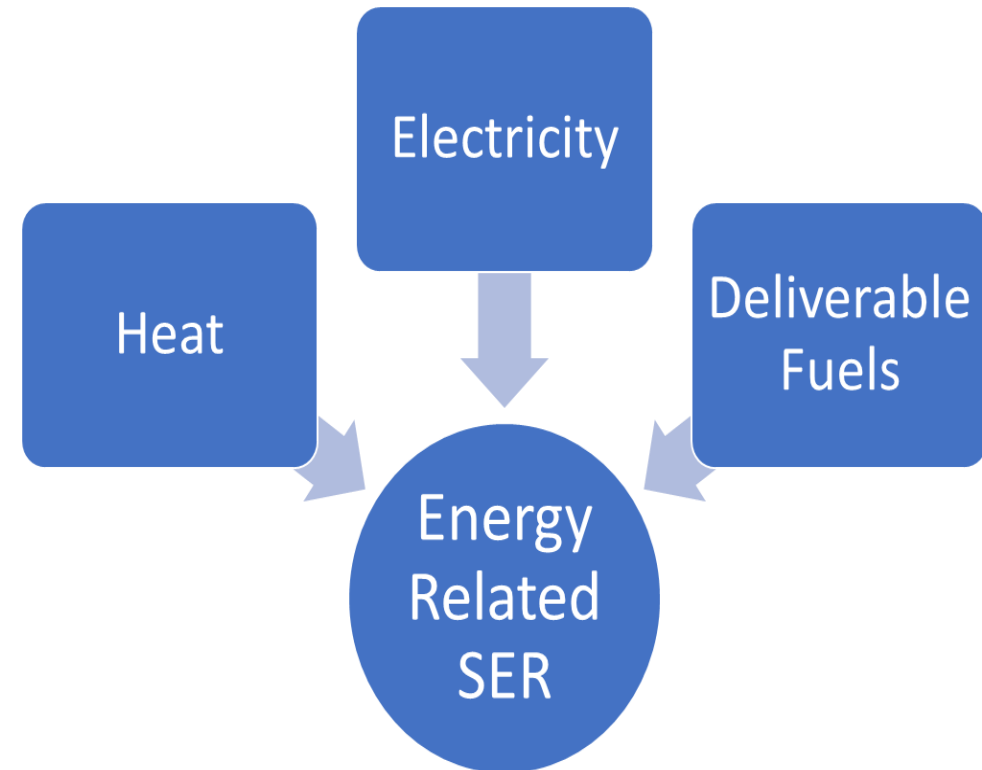

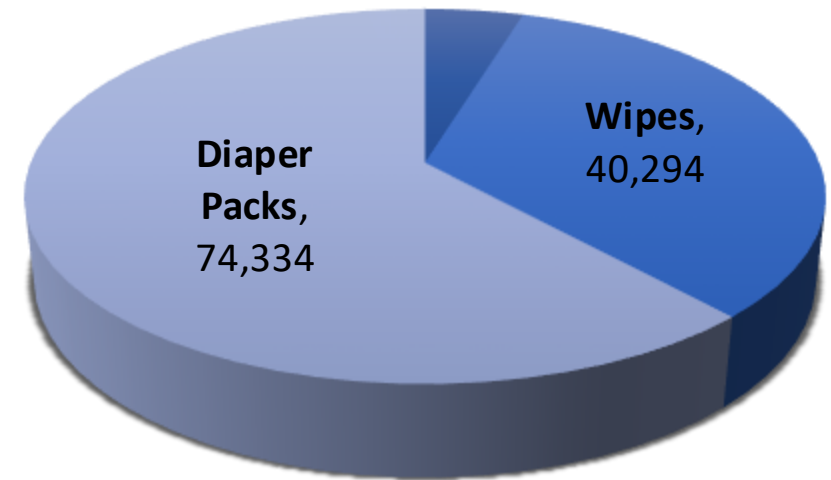


Diaper Bank - Fiscal Year 2024

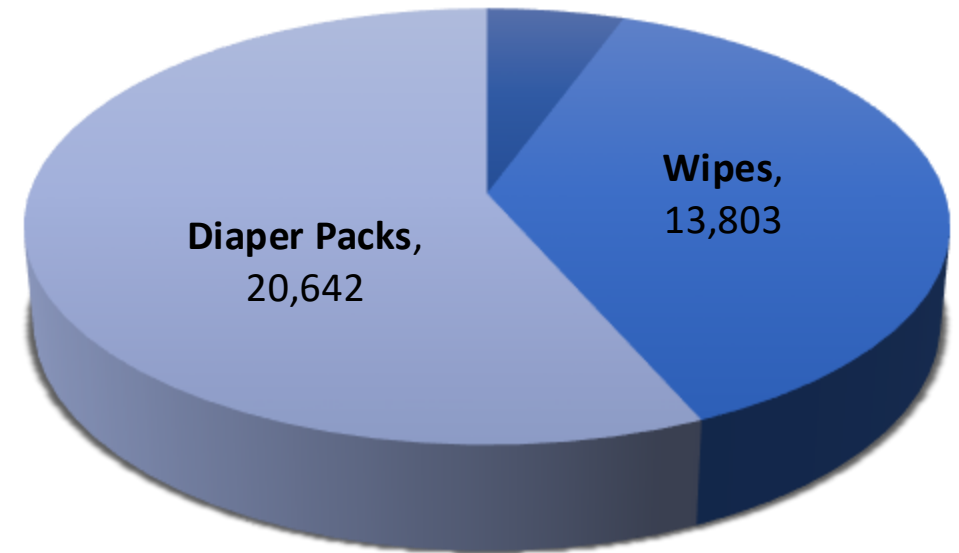
Diaper Bank - Fiscal Year 2025

Weatherization Assistance Program (WAP)

WAP in Michigan



Annual Production:

Weatherized Homes - **1,700 dwellings**

Program Expansion:

Annual Production Targets - **Up to 3,000 dwellings**

Eligibility Entities:

- Currently operated by 23 Community Action Agencies covering all 83 counties in Michigan

Client Eligibility:

- Individuals under 200% of the Federal Poverty Level

Funding Sources:

- Base Funds:
 - US Department of Energy (formula/IIJA)
- Supplemental Funds:
 - Low-Income Home Energy Assistance Program (LIHEAP)
 - Federal Recovery Funds (FRF)
 - At times, General Funds

Highlights of Michigan's WAP

Historical Impact: Program has served **Michigan families for more than 40 years** with continuous improvement refining approaches to achieve efficiency and safety. **Approximately 29,000 dwellings** have been weatherized in Michigan through WAP.

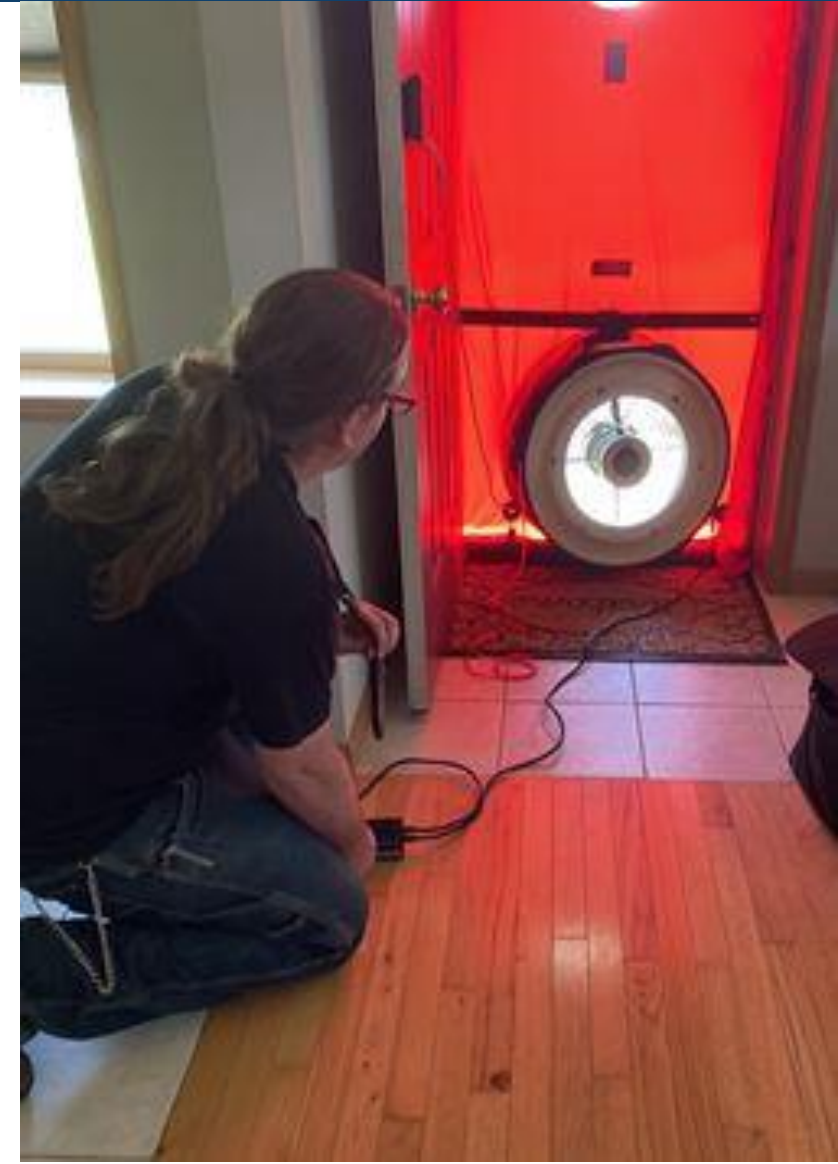
Home Stabilization: In recent years, funding has been available for home stabilization repairs ahead of Weatherization work. This allows more of the most vulnerable Michigan residents to be served and stay in homes that were previously in disrepair. (roof repairs, electrical updates/decommission knob and tube, mold mitigation)



Highlights of Michigan's WAP

Industry Experts: The Michigan WAP requires certifications that require high level of energy efficiency knowledge, setting a high bar for energy efficiency knowledge in the State.

Workforce Development: Michigan's WAP is building pathways to meaningful construction trade careers that offer family-sustaining wages. This workforce development investment strengthens local economies and creates long-term opportunities in the growing field of energy efficiency.
