

Community Services - \$61.1 million Gross (\$33.6 million GF/GP)

Grants to regional Area Agencies on Aging for the following supportive services and programs: access to local services, aging, and disability resource centers, locally determined needs, in-home services, adult daycare, health education, wellness screening, disease prevention services, elder abuse prevention, family caregiver support, long-term care ombudsman, and Medicare/Medicaid assistance. **In FY 2022-23, 13,263 older adults and caregivers were served through nutrition and in-home care services. Additionally, 279,938 older adults were served through locally determined needs assessments. In FY 2024-25, \$20.1 million Gross has been spent.**

Non-GF Fund Sources(s): Federal - Administration for Community Living/Administration on Aging; Title III- 25% match for admin costs, 15% match on services; Title XIX, Centers for Medicare & Medicaid Services/Medicaid Program- 50% federal match

Employment Assistance- \$3.5 million federal US Department of Labor funding

Grants to regional Area Agencies on Aging to administer federal Senior Community Service Employment Program to provide subsidized part-time community service interim employment opportunities for low-income seniors. Program is authorized through Title V of the federal Older Americans Act of 1965. Participants must be aged 55 or older and unemployed with a family income no greater than 125% of federal poverty income guidelines. Priority is given to veterans and those individuals 65 years of age or older with the greatest economic need. **FY 2022-23, 228 older workers participated in the Program. In FY 2024-25, \$926,400 has been spent.**

Non-GF Fund Sources(s): Federal- U.S. Department of Labor (Senior Community Service Employment Program)

Nutrition Services - \$50.0 million Gross (\$12.6 million)

Grants to regional Area Agencies on Aging for food and nutrition services for vulnerable elderly adults (60 and older) including at least one hot or other appropriate meal per day in a congregate setting or as a home delivered meal, and nutrition education services; federal cash and/or commodities for meal preparation supports congregate and home delivered meals; and funding for Senior Project FRESH Farmer's Market Nutrition Program. **On average, the Senior Nutrition Program annually serves more than 10.4 million meals to more than 87,120 adults throughout the state. FY 2024-25, \$16.8 million Gross has been spent.**

Non-GF Fund Sources(s): Federal- Senior Farmers Market Services Grant, Administration on Aging in cooperation with the U.S. Department of Agriculture (USDA) (60 years or older and more than 185% of

poverty rate) -no more than 10% on admin costs; Title III- 25% match for admin costs, 15% match on services; Private- Farmers market coupon purchases.

Respite care program- \$7.3 million Gross (\$400,000 GF/GP)

Grants to regional Area Agencies on Aging for respite care services to assist family caregivers providing care to an elderly person in need of constant supervision; provided in home or in an adult day care setting. **In FY 2022-23, funding from the program allowed 5,021 caregivers to receive 655,570 units of respite and adult day services. FY 2024-25, \$2.2 million Gross has been spent.**

Non-GF Fund Sources(s): Merit Award- interest and earnings from Michigan merit award trust fund investments, donations of money made to the trust fund from any source, and any money allocated as provided by law; Restricted- Senior Respite Care Fund (created in Treasury)- AAA receive as least \$25,000 or a proportional amount if funds are not available. Up 1% can be used for admin, if any remaining money, it is distributed according to a formula.

Senior volunteer service programs- \$4.8 million GF/GP

Grants to local agencies for the following programs established under the federal Corporation for National and Community Service: Foster Grandparent Program - low-income seniors (55 and older) who volunteer 20 hours per week to assist children and youth in need of personal attention and special help; a stipend is paid to volunteers. Retired and Senior Volunteer Program - community senior volunteers. Senior Companion Program - low-income seniors who provide 20 volunteer hours per week of individualized care and assistance to frail and at-risk adults; a stipend of \$2.65 per hour is paid to volunteers. **In FY 2022-23, there were senior volunteer programs in 65 counties statewide: Retired and Senior Volunteer Program (RSVP) had 2,418, Senior Companion Program and Foster Grandparent Program collectively had 1,000 volunteers. FY 2024-25, \$1.8 million Gross has been spent.**
