Our Local Road Network

- There are 112,376 miles of local roads in Michigan
 - 92% of all roads
- Cities and villages maintain 21,248 miles of road
 - Major Roads (6,311 miles)
 - Local Roads (14,937 miles)





Local Transportation Funding

- Act 51: 21.8% of the net Michigan Transportation Fund (MTF) revenue
 - \$734,069,200
- Federal Funds, Local Bridge Resources, Wetlands, Rail Grade Crossing
- Local Resources
 - General Fund Dollars
 - Local Millages
 - 91 cities (\$128M), 123 villages (\$12M)
 - Not reflective of true total
 - Not feasible for everyone

Maximizing Our Transportation Network

The Big Picture

- Our transportation network is more than just curb to curb
- We live in an increasing mobile environment
 - Increased demand for alternative modes of transit
 - Desire for walkable communities
- Infrastructure as an economic development tool
 - What are employers looking for?
 - What do employees need?
 - Where is talent locating?



A System Designed For All Users

Goals to Consider

- A system not solely based on how fast we move people and goods
- Should offer minimal conflicts between modes and has clear expectations for its users
- Should not create barriers to destinations or endanger a particular user group

The Time to Increase Funding for Transportation is Now!

Reasons to be optimistic

1. Amount of revenue
 - \$3 billion
2. Major policy issue
 - Sales tax at the pump
3. Local Resources
 - More for local roads

Neighborhood Roads Fund

A targeted approach to fix residential and neighborhood streets

- Funded by a 50-cent retail delivery fee
- Generates \$275M annually
- Distributed to local road agencies through a targeted formula
 - Directed at approximately 26,000 of the 112,000 miles of local roads
 - Targeted towards nonfederal aid eligible roads
 - Formula works with new or existing revenue
