The \$175,000 appropriation supports the continuation of the Victim Assistance Program (VAP), which provides crisis intervention and long-term support to victims of crime in Oakland County. This program has filled critical gaps in public safety and health, especially following mass violence incidents like the Oxford High School and Rochester Hills shootings. By supporting victims, first responders, and families, the program offers a clear public benefit that promotes healing, safety, and community resilience. It is an appropriate use of taxpayer money because it funds a public service that was previously

supported by federal and state grants, and now requires supplemental support due to increased demand. This appropriation does not violate Article IV, Section 30 of the Michigan Constitution, as it is not a gift or gratuitous payment to a private entity, but rather a lawful expenditure for services that fulfill a public function traditionally supported by government.

Dear Legislator,

Thank you for taking the time to meet with us to discuss a \$175,000 supplemental appropriation request to support the continuation of our Victim Assistance Program (VAP).

The Victim Assistance Program has been a critical part of Common Ground's services for over 20 years. Initially, VAP was supported by a Victim of Crimes Act (VOCA) grant called the CVAN grant. When the State of Michigan changed course and discontinued the CVAN grant program, the Common Ground Board voted to continue the VAP program through private fundraising due to the ongoing need for these services in our community.

By way of background, in the wake of the Oxford High School mass violence event on November 30, 2021, it was this privately funded staff from Common Ground who were at Oxford high school supporting first responders and school staff in the immediate aftermath of the tragedy. In the weeks and months that followed, Common Ground's advocates continued to support the victims and the greater Oxford community in their healing. Later, Common Ground managed a longer-term response with the support of the US Justice Department and Michigan VOCA administrators at MDHHS.

Fast forward to today, Common Ground runs three Resiliency Centers in Michigan, supporting the Oxford, East Lansing, and Rochester Hills communities. Like Oxford, Common Ground's Victim Assistance staff was again called after the shooting at the Rochester Hills splashpad to work with the Oakland County Sheriff's deputies to support the injured victims and their families. Advocates spread out to five area hospitals on that Saturday evening, sitting by the bedside of every injured victim for as long as they wanted and needed, some into the early hours of the morning. Then in the weeks following, they stayed in close contact with the victims, offering support, paying for rides, arranging services, and educating them about the support services available to them. None of these efforts were publicly funded but supporting these victims was the right thing to do and an honor for staff at Common Ground.

Fundraising is challenging, and while we have been able to rely on community support to prop up the program enough to meet basic community needs, the recent mass violence events mentioned above have made it very clear that we need additional funding to sustain and build this program to continue to meet the more complex needs of crime victims in Oakland County.

Thanks in advance for your consideration of this important appropriation.
