DOWNTOWN ADRIAN RIVERFRONT PLAN



The City of Adrian continues to expand on the 2019 Strategic Action Plan and the City of Adrian's Downtown Development Plan by envisioning development along the River Raisin. The initial phase has included rehabilitation of adjacent historic properties for housing and commerce, development of a public space, and expanded access to the Kiwanis Regional Trail.



The Park House is the rehabilitation of three downtown buildings that are being transformed into twelve apartments on the second and third floors and the ground floor will consist of a restaurant, retail, and a classroom space for a local college. This is a \$12,500,000 project with a \$3,500,000 contribution from the Enhancement Grant. Construction will be completed in 2025.



The Winter Street Walk and Bike Loop is a project that will connect the Kiwanis Regional Trail to the downtown via a protected bike loop. The project will calm traffic on Winter Street and project a downtown street setting to improve commerce and walkability. This project has a \$5,100,000 contribution from the Enhancement grant and a \$5,500,000 MDOT TAP Grant allocation. Construction will take place in 2026.



The Town Square is the development of a public space to include a gathering area, bandshell, microretail, and an art and sculpture park. This project has a \$2,500,000 contribution from the Enhancement Grant and a \$1,000,000 local private donation. Construction will take place in 2025.

Property acquisition from DTE and clean up of multiple sites is crucial to the success of the project. All properties are adjacent to the River Raisin, a major water way in southeastern Michigan.



Recent improvements to city infrastructure and addition of bike lanes connecting the regional trail to the downtown allows for increased focus on the riverfront and the areas environmental blight.

The high demand for housing has adversely affected the local market. Increasing housing stock will provide a growth opportunity for the community and local businesses.

The next phase of the project will be the development of the housing on the Winter Street. This will include the acquisition of additional adjacent property to the North. These properties will overlook the River Raisin and the future River Raisin Park. An important part of this phase will be the negation of the DTE - Citizens Gas property, the anticipated location of the future River Raisin Park.
