# Police Training Center

The City of Sterling Heights Police Department is transforming a former jail facility into a police training center to enhance officer preparedness, promote public safety, and ensure effective responses to diverse community challenges.

## Project Summary

The proposed renovation will transform the second floor of the former jail within the Law Enforcement Center into a dynamic, multi-functional training and operations hub. This modernized, 6,700 square foot facility will advance the City's vision of public safety that is equitable, responsive, and proactive.

The new Criminal Investigation Room will provide comprehensive investigative training and practical simulations, empowering officers to proactively address community safety challenges. Adjacent Training and Conference Rooms will serve as versatile spaces equipped with advanced technology to facilitate inclusive professional development, interagency workshops, and community-oriented safety meetings.

To encourage collaboration and proactive intelligence sharing, dedicated Interagency Offices for task forces like the Federal Anti-Narcotics Team of Macomb (FANTOM) and the DEA will be established, promoting cross-agency cooperation.

Recognizing the importance of officer wellness, a state-of-the-art Fitness and Wellness Center will proactively support physical health and stress management, contributing directly to improved officer responsiveness and equitable performance. Similarly, a dedicated Recreation Area will foster positive morale and team cohesion, essential for maintaining a motivated and community-focused department.

Together, these thoughtfully designed spaces will strengthen the City's commitment to a law enforcement model that is community-oriented, equitable in service delivery, and proactively responsive to the needs of all residents.
