**HOUSE SPECIAL COMMITTEE ON
ROADS AND ECONOMIC DEVELOPMENT**

Representative Jeff Farrington, Chair, called the meeting to order.

MEMBERS PRESENT: Representatives Farrington, Pettalia, Pscholka, LaFontaine, Afendoulis, Lane, Dianda.

Representative Pettalia moved to adopt the minutes from the June 2, 2015 meeting.

There being no objection, the motion prevailed by unanimous consent.

The Chair laid the following bills before the committee:

- HB 4605 (Pscholka) Individual income tax; administration; income tax revenue portion of the general fund; earmark to the transportation fund.
- HB 4606 (Potvin) Sales tax; distribution; portion of sales tax revenue; earmark to transportation fund.
- HB 4607 (Pettalia) State financing and management; funds; 21st century jobs fund; allow certain amount to be appropriated to the Michigan transportation fund.
- HB 4608 (Chatfield) Economic development; Michigan strategic fund; certain amount to be appropriated to Michigan transportation fund; allow.
- HB 4609 (Farrington) Individual income tax; credit; earned income tax credit; eliminate.
- HB 4610 (Aaron Miller) Counties; boards and commissions; requirement for competitive bidding by county road commissions on certain road projects involving townships; provide for.
- HB 4611 (Canfield) Transportation; funds; contracts entered into by state transportation department and local road agencies; change bidding requirements and allow state transportation department to borrow money from local road agencies.
- HB 4612 (Leutheuser) Vehicles; registration; registration fees; modify.

HB 4613 (Lauwers)	Highways; construction and repair; replacement warranties on road repairs; modify, and extend warranty requirement to local road agencies.
HB 4614 (LaFontaine)	Sales tax; collections; tax on motor fuel and alternative fuel; include in streamlined sales and use tax revenue equalization act.
HB 4615 (VerHeulen)	Transportation; motor fuel tax; motor fuel tax; modify.
HB 4616 (McCready)	Transportation; motor carrier fuel tax; flat tax rate; eliminate, and establish an 18-month limitation period for filing refund claims.

Representative Lauwers explained substitute (H-2) to HB 4613.

“(12) BEGINNING WITH THE FISCAL YEAR ENDING SEPTEMBER 30, 2016, THE DEPARTMENT SHALL DISTRIBUTE AN AMOUNT EQUAL TO THE DIFFERENCE BETWEEN THE AMOUNT EXPENDED ON ADMINISTRATIVE EXPENSES UNDER SUBSECTION (11) DURING THE FISCAL YEAR ENDING SEPTEMBER 30, 2014 AND 7% OF THE AMOUNT RECEIVED BY OR RETURNED TO THE DEPARTMENT FROM ANY SOURCE DURING THE FISCAL YEAR ENDING SEPTEMBER 30, 2014 AS FOLLOWS:

(A) TWO-THIRDS TO THE COUNTY ROAD COMMISSIONS OF THIS STATE.

(B) ONE-THIRD TO THE CITIES AND VILLAGES OF THIS STATE.” And renumbering the remaining subsections.

Representative Dianda moved to adopt the amendments to HB 4613 (H-2).
