MINUTES OF THE COMMITTEE  
ON  
LAW AND JUSTICE

The House Standing Committee on Law and Justice was called to order by Chairman Kesto.

Representative Lucido moved to adopt the minutes of June 6, 2017. There being no objection, the motion prevailed by unanimous consent.

Chairman Kesto laid the following bills before the committee:

HB 4547 (Kesto)                      Criminal procedure; sentencing guidelines; blood alcohol level requirement for certain alcohol-related offenses; eliminate sunset for .08 limit.

HB 4548 (Green)                      Crimes; intoxication or impairment; blood alcohol level requirement for certain alcohol-related driving violations; eliminate sunset for .08 limit.

Representative Graves explained the substitute (H-2) to HB 4547 and the substitute (H-2) to HB 4548.

Representative Graves moved to adopt substitute (H-2) to HB 4547. The motion prevailed, the vote being 12-0-0.

Sgt. Tim Fitzgerald, representing the Michigan State Police, submitted a card in support of HB 4355, but did not wish to speak.
