MINUTES OF THE STANDING COMMITTEE
ON TRANSPORTATION AND INFRASTRUCTURE

Tuesday, March 28, 2017 10:30 a.m. Room 521 House Office Building

Representative Cole, Chair, called the meeting to order.

Representative Alexander made a motion to accept the minutes of the meeting of March 21, 2017. No objections being offered, the minutes were accepted as presented.

The Chair laid the following bill before the Committee.

HB 4215 (Hughes) Traffic control; violations; unattended running vehicles; allow under certain circumstances.

Representative Hughes was present to answer questions regarding HB 4215.

Representative Webber made a motion to adopt HB 4215 (H-4).

Representative Chirkun offered the following amendment to HB 4215 (H-4).

1. Amend page 2, following line 1, by inserting:

"(3) IF AN INDIVIDUAL WHO HAS CONTROL OR CHARGE OF A MOTOR VEHICLE ALLOWS THAT MOTOR VEHICLE TO STAND UNATTENDED IN ANY PLACE WITH THE ENGINE RUNNING, AND IF ANOTHER INDIVIDUAL STEALS THAT MOTOR VEHICLE DURING THE PERIOD IT IS LEFT UNATTENDED WITH THE ENGINE RUNNING, THE INDIVIDUAL WHO ORIGINALLY HAD CONTROL OR CHARGE OF THE MOTOR VEHICLE IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH, IF THE INDIVIDUAL WHO STOLE THE MOTOR VEHICLE USES THAT MOTOR VEHICLE TO COMMIT MANSLAUGHTER

OR NEGLIGENT HOMICIDE." and renumbering the remaining subsection.

Representative Chirkun made a motion to amend HB 4215 (H-4).
