The House Standing Committee on Commerce and Trade was called to order by the Chair.

Chairman Leutheuser requested attendance be called to establish a quorum of the appointed committee members:

Representative Garcia moved to adopt the May 22nd, 2018, minutes. There being no objection, the motion prevailed by unanimous consent.

The Chair laid Senate Bill No. 916 before the committee:

SB 916 (Kowall) Occupations; junk and secondhand dealers; automatic recycling kiosks; regulate.

Representative Garcia moved to report **Senate Bill No. 916** with recommendation. The motion prevailed **11-1-0**.

The Chair laid House Resolution No. 339 before the committee:

HR 339 (Barrett) A resolution to urge the President of the United States to aggressively enforce the terms, conditions, and intent of the Buy American Act and to urge no waivers to the act be granted.

Representative Barrett testified in support of the resolution. Questions and discussion followed.

Representative Garcia moved to report **House Resolution No. 339** with recommendation. The motion prevailed **12-0-1**.

HB 4224 (Kelly) Crimes; other; resale of event tickets at higher or lower prices; allow.

Representative Kelly testified in support of the bill. Questions and discussion followed.

Representative Kesto moved to adopt substitute **(H-1)** for **House Bill No. 4224**. The motion prevailed **13-0-0**.

Diane Willcox and Jared Bradford, representing the Wharton Center, and Katie Peters, representing Live Nation, all testified in opposition to the bill, as introduced. Questions and discussion followed.

Barb Farrah, representing the Michigan International Speedway, submitted a card in opposition to the bill, but did not wish to speak.

Representative Camilleri made a motion to excuse absent members. No objections being offered, absent members were excused.

There being no further business before the committee, the Chair adjourned the meeting at 11:44 a.m.
