MINUTES OF THE COMMITTEE
ON
COMMERCE AND TRADE

Tuesday, September 25, 2018 10:30 a.m. Room 519 House Office Building

The House Standing Committee on Commerce and Trade was called to order by the Chair.

Chairman Leutheuser requested attendance be called to establish a quorum of the appointed committee members:

Representative Hornberger moved to adopt the May 29th, 2018, minutes. There being no objection, the motion prevailed by unanimous consent.

The Chair laid House Bill No. 4224 before the committee:

HB 4224 (Kelly) Crimes; other; resale of event tickets at higher or lower prices; allow.

Chairman Leutheuser discussed the proposed substitute before the committee.

Representative Greimel moved to adopt substitute (H-2) for **House Bill No. 4224**. The motion prevailed **14-0-0**.
