MINUTES OF THE COMMITTEE
ON
REGULATORY REFORM

Wednesday, May 03, 2017 10:30 a.m. Room 519 House Office Building

The House Standing Committee on Regulatory Reform was called to order by the Chair.

Members present: Reps. Iden, Bellino, Crawford, Leutheuser, Theis, Webber, Griffin, Hauck, Hoitenga, Reilly, Moss, Dianda, Chirkun, Liberati, Love.

Absent/Excused: Rep. Jones.

Representative Moss moved to adopt the minutes of April 19, 2017. There being no objection, the motion prevailed by unanimous consent.

Representative Bellino moved to adopt the minutes of April 26, 2017. There being no objection, the motion prevailed by unanimous consent.

The Chair laid SB 158 before the committee:

SB 158 (Jones) Occupations; business licensing and registration; licensure of used motor vehicle parts dealers; exclude certain businesses regulated under the natural resources and environmental protection act.

Vice Chair Bellino assumed the gavel at 10:36 a.m.

Nick Capone from the office of Senator Jones, Sarah Howes of the Michigan Department of Natural Resources, and Rhonda Oyer of the Michigan Department of Environmental Quality testified in support of the bill. Questions and discussion followed.

Chairman Iden assumed the gavel at 10:40 a.m.

Adrian Cazal representing the Michigan Waste and Recycling Association submitted a card in support of the bill but did not wish to speak.

The Chair laid SB 126 before the committee:

SB 126 (Kowall) Occupations; real estate; continuing education hours for real estate brokers and salespersons; revise requirements.

The Chair indicated that Senator Kowall's office provided written testimony in support of the bill.

Brian Westrin testified in support of the bill on behalf of the Michigan Realtors Association. Questions and discussion followed.

The following people submitted cards in support of the bill but did not wish to speak:

Frank Waters representing the Michigan Department of Licensing and Regulatory Affairs

The Chair laid HB 4169 before the committee:

HB 4169 (Brann) Liquor; licenses; prohibition on issuing license within 500 feet of church or school; extend exemption to licenses issued or renewed before certain date.

Dave Worthams representing the Michigan Bankers Association submitted a card in support of the bill but did not wish to speak.

Representative Dianda moved to report House Bill 4169 with recommendation. The motion prevailed 15-0-0.
