MINUTES OF THE COMMITTEE
ON
REGULATORY REFORM

Wednesday, May 16, 2018 10:30 a.m. Room 519 House Office Building

The House Standing Committee on Regulatory Reform was called to order by the Chair.

Members present: Reps. Iden, Bellino, Kesto, Crawford, Theis, Webber, Griffin, Hauck, Hoitenga, Reilly, Moss, Dianda, Chirkun, Liberati, Love, Jones.

Absent/Excused: None.

Representative Moss moved to adopt the minutes of May 9th, 2018. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4742 and HB 4743 before the committee:

HB 4742 (Tedder) Crimes; gambling; fantasy sports betting; allow.

HB 4743 (Miller) Gaming; other; fantasy contests act; create.

Representative Tedder and Representative Miller testified in support of their bills. Questions and discussion followed.

Scott Ward, representing Fan Duel and Draft Kings, testified in support of the bills.

The Chair laid HB 5224 before the committee:

HB 5224 (Yaroch) Occupations; barbers; education and training requirements for cosmetology and barber licensing; revise.

Robert Morey, representing the Flint Institute of Barbering, submitted a card in opposition to the bill, but did not wish to speak.

Walter Lupu, representing the Barber/Styling College, submitted a card in opposition to the bill, but was unable to testify due to time constraints.

Adam Jencic, representing the Students of Barbering, submitted a card in opposition to the bill, but did not wish to speak.

Sam Boumis, representing Douglas J Aveda, submitted a card in support of the proposed substitute, but did not wish to speak.

Representative Griffin moved to adopt substitute (H-1) to House Bill 5224. The motion prevailed 15-0-1.

Representative Love offered the following amendments to House Bill 5224 (H-1):

1. Amend page 4, line 15, by striking out “**1,000**” and inserting “**300**”.
2. Amend page 8, line 21 after “**THAN**” by striking out “**1,000**” and inserting “**300**”.

Representative Love spoke to her amendments.

Representative Love moved to adopt the amendments to House Bill 5224 (H-1). The motion failed 5-10-1.
