The House Standing Committee on Regulatory Reform was called to order by the Chair.

HB 4668 (Kesto)      Liquor; other; reference to grape and wine council; revise to reflect change in council name.

The Chair testified in support of the proposed substitute H-2 to House Bill 4667.
