MINUTES OF THE COMMITTEE
ON
REGULATORY REFORM

Wednesday, November 1, 2017 10:30 a.m. Room 519 House Office Building

The House Standing Committee on Regulatory Reform was called to order by the Chair.

Members present: Reps. Iden, Bellino, Crawford, Leutheuser, Theis, Webber, Griffin, Hauck, Hoitenga, Reilly, Moss, Dianda, Chirkun, Liberati, Love, Jones.
Absent/Excused: None.

Representative Moss moved to adopt the minutes of October 25th, 2017. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4813 before the committee:

HB 4813 (Vaupel) Animals; other; training requirements for animal control shelters, animal protection shelters, and class B dealers to obtain a limited permit to buy, possess, and administer certain animal tranquilizers and sodium pentobarbital; revise.

Representative Leutheuser moved to report House Bill 4813 with recommendation. The motion prevailed 14-1-1.

The Chair laid HB 5175 before the committee:

HB 5175 (Brann) Liquor; licenses; qualifications of an eligible merchant that may fill and sell growlers of beer; revise.

Representative Brann testified in support of his bill. He was joined by Kerry Krone, representing the Michigan Liquor Control Commission, in answering questions from committee members. Further questions and discussion followed.

Jarrett Skorup, representing the Mackinac Center for Public Policy, testified in support of the bill.

The following people submitted cards in support of the bill but did not wish to speak:

Scott Graham, representing the Michigan Brewers Guild.

Amy Drumm, representing the Michigan Retailers Association.

Brett Visner, representing the Michigan Beer and Wine Wholesalers Association, submitted a card indicating the association is neutral on the bill but did not wish to speak.

Kerry Krone and Julie Wendt, representing the Michigan Liquor Control Commission, submitted a card indicating the commission has no position on the bill but did not wish to speak.

The Chair laid SB 297 before the committee:

SB 297 (Horn) Occupations; individual licensing and regulation; presentation of identification to certain government officials; require, and revise scope of practice for electricians.

Melanie Ellison, Legislative Aide for Senator Horn, and Todd Tennis, representing the IBEW Michigan Conference, testified in support of the bill. Questions and discussion followed.

Marnie Wills and Keith Lambert, representing the Michigan Department of Licensing and Regulatory Affairs, testified in support of the bill.

Mike Crawford, representing the Michigan Chapter National Electrical Contractors Association, submitted a card in support of the bill but did not wish to speak.

There being no further business before the committee, the Chair adjourned the meeting at 10:59 a.m.
