MINUTES OF THE COMMITTEE
ON
REGULATORY REFORM

Wednesday, December 6, 2017 10:30 a.m. Room 519 House Office Building

The House Standing Committee on Regulatory Reform was called to order by the Chair.

The Clerk read letters from House Speaker Tom Leonard which removed Representative Leutheuser from and appointed Representative Kesto to the Regulatory Reform Committee.

The Chair recognized Representative Kesto who thanked the Speaker and the Chair for being appointed to the committee.

The Chair laid HB 5236 before the committee:

HB 5236 (Iden) Occupations; accounting; certified public accountants; continuing education requirements; modify, and make other general revisions.

The Chair explained the changes made by the proposed substitute (H-1).

Representative Theis moved to adopt substitute (H-1) to House Bill 5236. The motion prevailed 14-0-0.

2. Amend page 14, line 22, after **"THAT"** by striking out **"THAT"** and inserting **"LICENSING JURISDICTION"**.

Representative Hauck moved to adopt the amendments to House Bill 5236 (H-1). The motion prevailed 14-0-0.
