

Fee Sunsets

- Water Resources
 - Ordinary High Water Mark Establishment Fee
 - Floodplain Application Fee
 - Submerged Lands
 Application Fees
 - Great Lakes Shoreline Permits Fee
 - Pre-Application Meeting Fee
 - Inland Lakes and Streams
 Application Fee

- Surface Water Quality

Water Resource Fee Sunsets

- Consolidated permit application fees
- Includes 6 separate fees
- \$50 \$2,000 per fee
- Paid by permit applicants utilities, drain commissioners, agriculture and other businesses, property owners
- Michigan one of only two states to assume 404 program (wetlands, inland lakes, streams)



Water Resources

- Maintain state management of our resources
 - Ensure best management of Michigan's water resources while growing our economy
 - Implement Wetlands Program and PA 98 of 2013
 - Conduct agricultural wetlands outreach



Surface Water Quality Fee Sunsets

- Includes surface water discharge, storm water discharge and sewer expedited permit fees
- Paid by anyone discharging wastewater municipalities, businesses, CAFOs, construction sites
- Includes both application and annual fees
- \$75 \$213,000 (DWSD)
- Funds major water pollution control activities



Surface Water Quality

- Improve water quality to support recreational and commercial uses
 - Significant increase in wet weather events and storm intensity
 - Address raw sewage discharges through NPDES Program and make 90% of permits current (present = 65%)
 - Mobile and efficient workforce building on MiWaters

Surface Water Quality

- Ensure "Pure Michigan" recreational experience for current and future generations:
 - Real-time beach monitoring
 - Development and implementation of watershed plans
 - Beaches always open


Surface Water Quality – Beach Monitoring

- Builds on 2014 real-time monitoring pilot at Metro Beach
- Uses eDNA technology
- Partner with local health departments & MSU
- Labs statewide
- Know it is safe before swimming!

Surface Water Quality - Lake Erie

- Reemerging problem: Harmful algal blooms
- Toledo drinking water supply shut down in August 2014
- FY16 focus on HAB monitoring technology

Groundwater Discharge Fee Sunset

- Charged on about 1,000 wastewater discharges to groundwater annually
- Paid by small municipalities, businesses, food processors
- \$200 \$3,650 annual fee
- Protects drinking water



Groundwater – Water Use

- Ensure best management of Michigan's water resources while growing our economy
 - Refine Water Withdrawal Assessment Tool
 - Document methods for data collection
 - Provide tools for communities to resolve conflicts
- Water Use Advisory Council report issued December 2014
 - Includes short- and long-term projects and strategy


