

- Provide excellent service to all of our customers




OOGM PROGRAM AREAS:


Oil & Gas

- Permit fee, surveillance fee
 Orphan Wells
- Portion of oil & gas severance tax
 Mineral Wells
- Permit Fee, Annual Well Fee
 Mining
- Permit fee, tonnage fee; portion of nonferrous metal severance tax
 No GF/GP Funds since 2002



Oil & Gas Program

- 60,000 Wells since 1925
- Active Wells:
 - 3900 oil
 - 10,600 gas
 - 1400 water injection & disposal
 - 2800 gas storage

HYDRAULIC FRACTURING

New Rules - March 2015

- Water use
- Monitoring & reporting
- Chemical disclosure
- Baseline groundwater sampling

DRILLING IN HIGH-DENSITY RESIDENTIAL AREAS

- Recent concerns in SE Michigan
- DEQ must protect environment while respecting property rights
- New requirements
 - Alternatives analysis
 - Notification
 - Quality of life protections

INJECTION WELLS

- Dispose of waste fluids or increase oil recovery
- Regulated by EPA & OOGM
- Michigan seeking primacy from EPA for Class II wells (associated with oil and gas production)
- 1400 Class II wells in Michigan
 - > 800 Brine disposal
 - 600 Enhanced oil recovery
- 39 States have primacy




Oil & Gas Regulatory Fund


- Goal: maintain balance of \$7 million to cover price changes
- Current expenditure = \$8.5 million
- Permit fees + gas storage well fees + interest = \$100,000/year +/-
- Surveillance fees = remainder


SURVEILLANCE FEE

- Percentage of gross value of production of oil and gas
- Rate set in November for upcoming calendar year
- Based on volume and price projections
- Capped at 1%










E TANK
