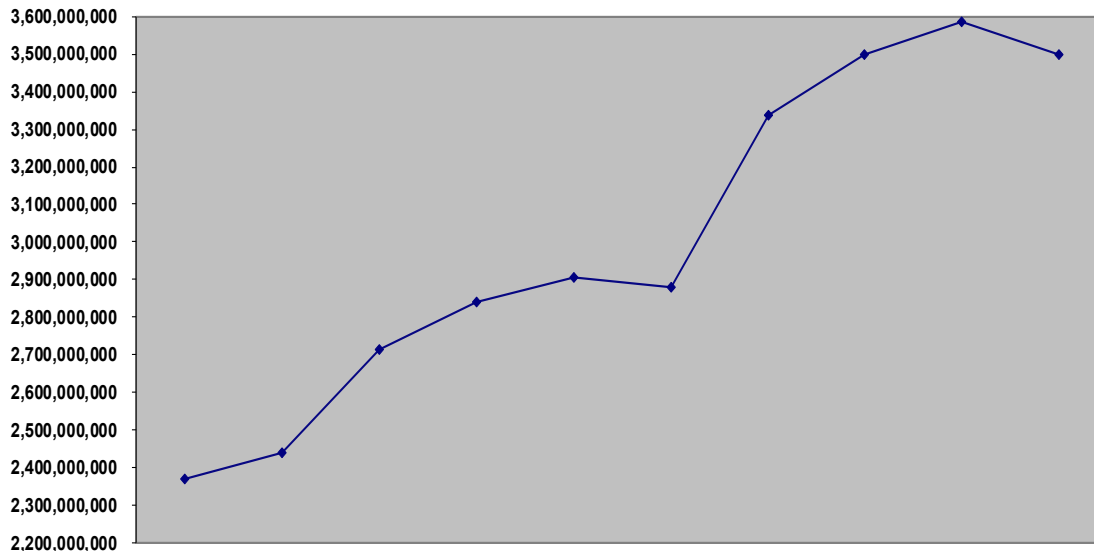

FY26 Governor's Recommendation

Investment

Key Strategic Staffing Needs

- 4 FTE in Central Operations to adequately support technology efforts such as our new branch office system (CARS) which is continually upgraded to avoid another large system replacement in the future along with other new technology that is being added
- 8 FTE in Legal Services due to an increase in fraud, regulator non-compliance and audit findings in this area. Filling these positions will allow us to ensure customer protection and improve our service for Michiganders
- Currently have approximately 43 appropriated unfunded FTE
- Fixed fee restricted revenue collections have not kept up with inflationary cost increases over the last 20 years
- Does not increase overall FTE included in the budget

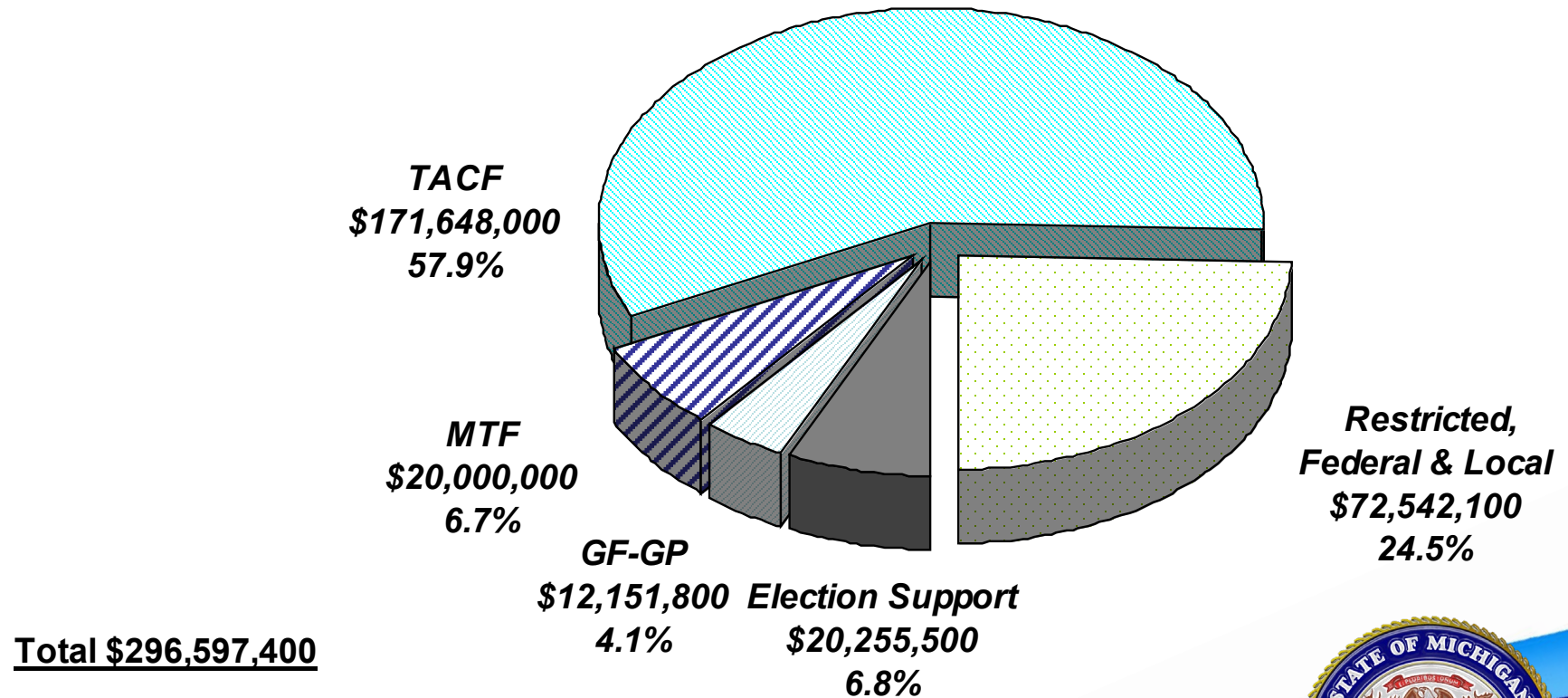

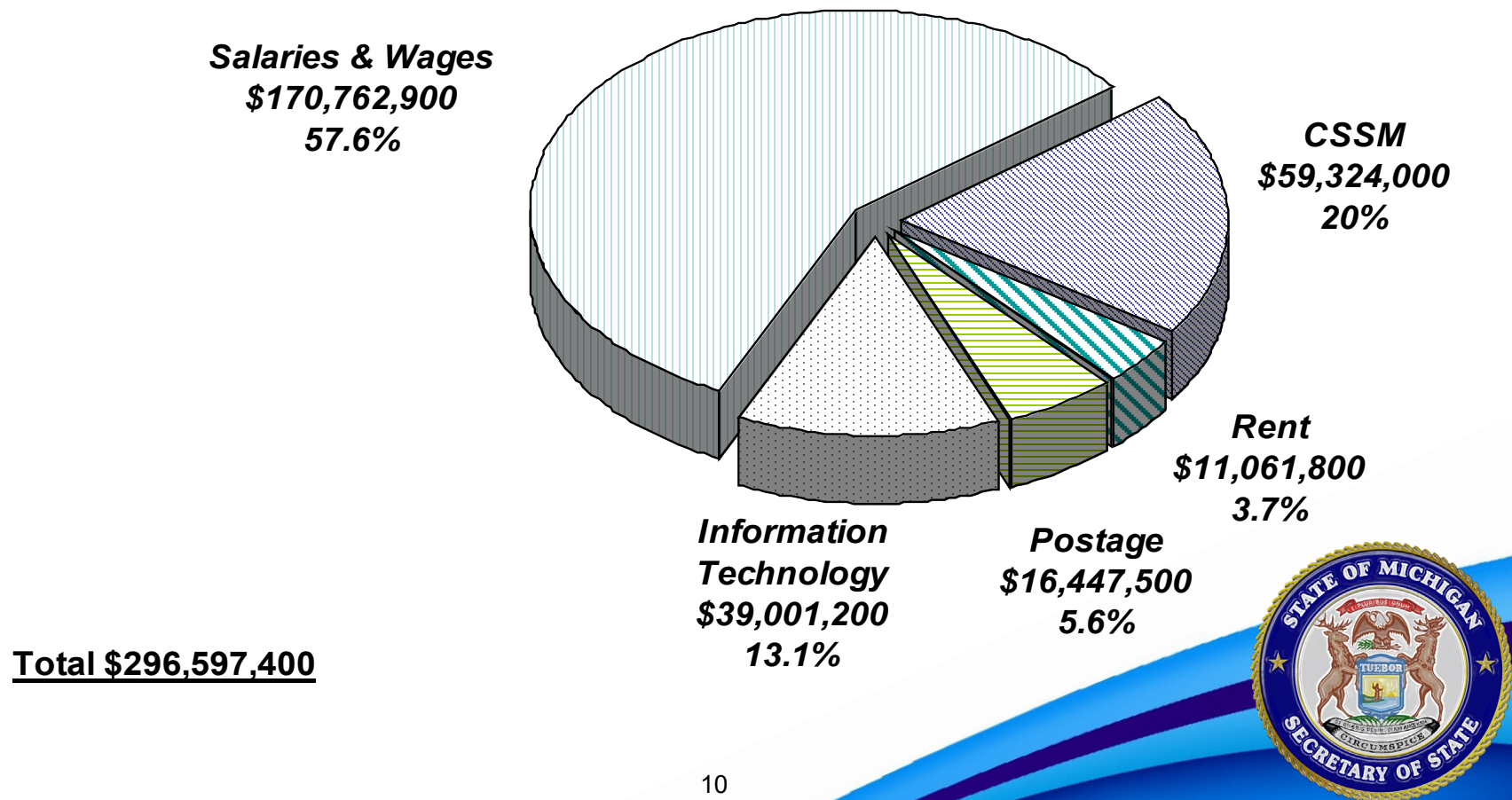
MDOS Funding Sources

FY25 Supplemental Request

HAVA Security Grant Authorization - \$9.6M

- Reappropriation of \$5.72M of unspent previously appropriated grant funding in a work project that expired in FY24
- \$1M in grant funding received in FY24 to support election security related initiatives plus interest earned
