PACC

- Autonomous agency under the Department of Attorney General
- Established in 1972 by MCL 49.101 *et seq.*
- Mandated by MCL 49.109 “The council shall keep the prosecuting attorneys and assistant prosecuting attorneys of the state informed of all changes in legislation, law and matters pertaining to their office, to the end that a uniform system of conduct, duty and procedure is established in each county of the state.”
- PACC serves and trains an estimated 765 Prosecutors and Assistant Prosecutors and approximately 800 prosecution support staff and victim advocates.

Publications

Assistance

- Immediate legal research: Instant legal advice on current legal issues such as MRTMA, juvenile life without parole, and upcoming issues including civil asset forfeiture, raise the age, bond reform, as well as assistance with legal issues arising from trials, motions and appeals.
- Continuous updates on various issues: MSP Laboratory Policy Changes, SORA, case law and legislative changes.

PACC: INFORMATION TECHNOLOGY SERVICES


Adult & Juvenile Case Tracking

- A comprehensive computer software package used by 78 of the 83 prosecutor's offices, and the Attorney General's office
- Supports 1400 users
- Specifically designed for Michigan's legal system and the needs of Michigan's prosecutors
- Generates all documents, warrants, subpoenas, and court notices from an integrated database
- Electronically tracks victim rights and to assist prosecutors in providing those rights to victims
- Links the county prosecutor systems with the State Police and the Department of Corrections
- 24/7 help desk support


NextGen

- Will replace ACT/JCT
- CJIS Compliant
- Faster Discovery
- Cloud based
- Allows for information to be shared across prosecutors' offices, law enforcement agencies including MSP, local courts and SCAO, Department of Corrections
- Will have portals allowing defense attorneys to obtain discovery electronically and for victims to obtain court dates and case updates.
- Expected roll out starting third quarter 2020
- Statewide implementation tentatively first quarter 2021


PACC FTE COUNT
