HOUSE APPROPRIATIONS SUBCOMMITTEE ON **HEALTH AND HUMAN SERVICES**

DATE: Wednesday, April 19, 2017

Call to Order

Representative Edward Canfield, Chair, called the meeting to order at 12:15 p.m.

Attendance

Approval of Minutes

Representative Allor made a motion to approve the minutes of the March 15, 2017 Subcommittee meeting. There being no objection, the minutes were adopted.

Consideration of HB 4238

The meeting was scheduled for decision-making on the Department of Health and Human Services (DHHS) budget for FY 2017-18. The following documents were provided to the Subcommittee, as prepared by the House Fiscal Agency:

Summary of the House Subcommittee Chair's Recommendation for HB 5348 (H-1) Draft 1
