# Children's Services Agency

- State-administered child welfare system which oversees all child welfare services for children and their families.
  - 83 counties (dual and tri-county configurations)
  - 5 Business Service Center (BSC) regions
  
- Michigan Department of Health and Human Services
  - Employs approximately 3,710 field and central office staff.
  - Administers contracts to provide foster care, licensing and adoption services with approximately 56 agencies.
  
- Children's Services Agency
  - Children's Protective Services
  - Foster Care and Licensing
  - Adoption

# Children's Protective Services

Investigates all allegations of suspected child abuse or neglect by a parent, legal guardian or any other person responsible for the child's health or welfare, and provides services to prevent removal from the parental home.

## ➤ FY 2018 Statistics:

- Complaints received: 171,388 (2.5% increase from FY17)
- Complaints investigated: 96,067 (5.5% increase from FY17)
- Cases with a preponderance finding: 25,654 (15% of all complaints received)

## ➤ Accomplishments:

- Successful development and implementation of a CPS mobile application and Supervisory Control Protocol.
- Centralized Intake launched Michigan's Online Reporting System, providing mandated reporters with a quick and efficient option for reporting suspected child abuse and neglect.

## ➤ Update on FY 2019 Supplemental Appropriation:

- Hiring 175 CPS staff.
- Technology and special projects.

# Foster Care

MDHHS and private agency partners provide foster care services focused on ensuring the safety, permanency and well-being of all children in care.

## ➤ Statistics:

- As of February 28, 2019, MDHHS was responsible for care and supervision of 13,489 children.
- Number of children placed in out-of-home care in FY18: 6,969

## ➤ Accomplishments:

- Continued collaboration with the West Michigan Partnership for Children for the care and supervision of all children under foster care jurisdiction in Kent County as part of a performance based funding pilot.
- Michigan is meeting 4 out of 5 national permanency measures.
- Implemented Regional Resource Teams statewide with locations in each BSC.
- Paying unlicensed relative providers as of April 1, 2019.

# Adoption

Approximately 3,000 Michigan foster children are legally free with a goal of adoption at any given time. Of those children, over 300 do not have an identified adoptive family.

## ➤ Statistics:

- In 2018, 2,002 children were adopted.
- The Adoption Subsidy Office administers approximately \$206 million each year.
- Approximately 95% of children who are legally free for adoption qualify for Michigan's Adoption Assistance program.

## ➤ Accomplishment:

- Eight regional Post Adoption Resource Centers continue to provide services statewide.

# Strengthening Child Welfare in Michigan

Continued improvements are needed to the MiSACWIS system to address functionality and usability.	CSA is working with DTMB to provide a comprehensive plan to address concerns and enable child welfare staff to focus on serving families.

# Strategic Priority: Achieve Permanency within 12 months

## Foster Care Supportive Visitation

### Context

- Michigan is not meeting the standard for permanency in 12 months for children entering care: 28.9% (standard is 40.5%). (University of Michigan Child and Adolescent Data Lab- September 2018).
- Children had visits of sufficient frequency with their parents only 60% of the time. (ISEP reporting period 13).

### Action

- Foster Care Supportive Visitation provides evidence-based in-home parent education.
- Builds on parent's strengths to increase parenting skills, capacity and confidence.
- Promotes timely permanency through reunification.
- Provides worker relief.
- ***Executive Recommendation: \$5.9 million Gross and GF/GP***

# Strategic Priority: Achieve Permanency within 12 months

## Foster Care Supportive Visitation

### Investment Detail

- *Executive Recommendation: \$5.9 million Gross and GF/GP*
- Investment includes \$5.75 million in contract increases to provide services to children and families and \$163,700 for 1 full time FTE.

- Departmental Manager 14 would be dedicated to the development, technical assistance and monitoring of these contracts.

# Strategic Priority: Achieve Permanency within 12 months

## Building Community Partnerships Parent Partner Program

### Context

- Michigan is not meeting the standard for permanency in 12 months for children entering care: 28.9% (standard is 40.5%). (University of Michigan Child and Adolescent Data Lab- September 2018).
- Children had visits of sufficient frequency with their parents only 60% of the time. (ISEP reporting period 13).

### Action

- Parent Partner program provides 6 months of support focused on empowering parents to:
  - Advocate for their family.
  - Successfully navigate the child welfare system.
  - Build a support network through utilization of community-based resources.
- Promotes timely permanency through reunification.
- ***Executive Recommendation: \$975,000 Gross and GF/GP***
  - ***Investment is contracted services provided to children and families.***

# Strategic Priority: License Relative Foster Care Providers

## Relative Provider Licensing Incentive

### Context

- ISEP section 6.18 requires Michigan to license 85% of relative providers within 180 days of placement: 30.1% in ISEP 13.
- ISEP section 6.19 requires that 80% of relative providers are either licensed or enrolled in the licensing process: 37.6% in ISEP 13.

### Action

- Relative Provider Licensing Incentive allows relative providers who become licensed foster parents within 180 days of placement to receive an incentive payment of \$1,000.
- This will assist in incentivizing relatives to become licensed following the April 1 implementation of payments for unlicensed relative providers.
- Licensure provides additional levels of background checks, more comprehensive assessments as well as training and supports to help ensure child safety and well-being.
- ***Executive Recommendation: \$1.76 million Gross and GF/GP***
  - ***Investment is a direct benefits to relative providers.***
